An Ordinance Concerning Annexation

THE CITY OF GRANITE FALLS DO ORDAIN AS FOLLOWS:

That the following described land which abuts with the incorporated land of the City of Granite Falls, County of Yellow Medicine, State of Minnesota, is declared annexed to the City of Granite Falls,

Beginning at the Northwest corner of the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section Thirty Three (33), Township One Hundred Sixteen (116) North of Range Thirty Nine (39) West of the 5th P.M.; thence South Eighty Seven Degrees and Fifty Five Minutes East along the quarter line for a distance of Thirteen and Seventy Six One-hundredths (13.76) Feet; thence South along the West line of 17th Street a distance of Six Hundred Eight and thirty one hundredths (608.30) feet; thence West a distance of Three Hundred Seventy Five (375) feet; thence North Six Hundred Ninety (690) feet; thence East Three Hundred Sixty One and Twenty Four One Hundredths (361.24) feet; thence South along the section line Eighty One (81) feet to the point of beginning; and containing approximately Five and Ninety One one hundredths (5.91) acres.
