

ORDINANCE NO. 202

AN ORDINANCE ANNEXING CERTAIN LANDS ABUTTING
UPON THE VILLAGE OF MAHTOMEDI AND EXTENDING
THE VILLAGE BOUNDARIES TO INCLUDE THE SAME.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DOES
ORDAIN AS FOLLOWS:

Section 1. That pursuant to those certain petitions signed by all of the owners of the following described properties containing less than two hundred acres, abutting upon the Village of Mahtomedi, requesting the annexation of said lands to said Village; and it appearing that such annexation will be to the best interests of the Village and of the territories affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include the following described properties:

Lot Thirteen (13) of Hanson's Addition to the Town of East Shore, Washington County, Minnesota; together with the South half of Iris Street adjoining the North line of the above described property and the North half of Hickory Street adjoining the South line of the above described property.

and

That part of Lot Fourteen (14) of Hanson's Addition to the Town of East Shore, Washington County, Minnesota described as follows:

Commencing at the Southwest corner of said Lot Fourteen (14), thence North along the West line of said lot a distance of 100 feet, thence East, parallel to the South line of said lot 110 feet to the East line of said lot, thence South along the East line of said lot to the Southeast corner of said lot, thence West along the South line of said lot to the point of beginning; together with the East half of Warner Road adjoining the West line of the


above described property and the North half of Hickory Street adjoining the South line of the above described property.

And that said described territories are hereby made a part of the Village of Mahtomedi as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County, the Secretary of State of the State of Minnesota, and with the Minnesota Municipal Commission, and from and after its publication.
