ORDINANCE NO. 5/4/

An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation of the State of Minnesota.

WHEREAS, A petition has been filed with the City of willmar, Minnesota, seeking the annexation to said City of the following described lands:

That part of the Northwest Quarter of the Northwest Quarter of Section 16, Township 119, Range 35, Kandiyohi County, Minnesota, bounded by the Great Northern Railway right-of-way on the South; County Road No. 5 on the West; Gorton Avenue Northwest on the North; and Calvary Church Cemetery on the East; and further described as follows:

That part of said Northwest Quarter of the Northwest Quarter lying North of the Northerly right-of-way line of the Great Northern Railway Company;

WHEREAS, The City Council of the City of Willmar, Minnesota, determines and finds that the annexation of said territory will be to the best interests of the City of Willmar and of the territory affected,

NOW THEREFORE, Be It Ordained by the City Council of the City of Willmar, Minnesota as follows:

Section 1. Annexation. The property described above is hereby annexed and included within the City of Willmar, Minnesota, as effectually as if it had been originally a part thereof.

Section 2. Best Interests of City of Willmar. That the annexation will be to the best interests of the City of Willmar, Minnesota, and of the territory affected.

Section 3. Abuts on City Limits. That the property above described abuts on the City Limits and is so conditioned as properly to be subject to City government.

Section 4. Zoning. The area above described shall be zoned LI - Light Industry.

Section 5. Effective Date. This ordinance shall take effect and be in full force from and after filing a copy hereof with the Minnesota Municipal Commission, the Clerk of the Township of Willmar, the Kandiyohi County Auditor, and the Secretary of the State of Minnesota.
