ORDINANCE NO. 517

(D-F)

An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation of the State of Minnesota, to Include Certain Land Not Exceeding 200 Acres.

WHEREAS, the following described land is completely surrounded by the City of Willmar, Minnesota, and

WHEREAS, It is proposed to annex by virtue hereof to the said City of Willmar, said property, all of which said property is in Kandiyohi County in the State of Minnesota, and

WHEREAS, The said property to be annexed consists of 39.0 acres described as follows:

That portion of Govt. Lot 2 in the Southeast quarter of the Southwest quarter of Section 9, T119N, R35W; and

That portion of Foot Lake in the North half of Section 16, T119N, R35W, all in Kandiyohi County, State of Minnesota.

NOW THEREFORE, The City Council of the City of Willmar hereby determines, ordains and declares as follows:

Section 1. Best Interests of City of Willmar. That the annexation will be to the best interests of the City of Willmar, Minnesota, and of the territory affected.

Section 2. Abuts on City Limits. That the property above described abuts on the City limits, and is so conditioned as property to be subject to City government.

Section 3. Annexation. That the said property is hereby annexed to, and included within the City of Willmar, Minnesota, as effectually as if it had originally been a part hereof.

Section 4. Zoning. The area above described shall be zoned Farm Residence.

Section 5. Effective Date. This ordinance shall be final and shall take effect and be at full force from and after filing a certificate hereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota, and the Secretary of the State of Minnesota, and from and after its passage and publication.
