ORDINANCE NO. 519

An Ordinance Extending the Corporate Limits of the City of Willmar, A Municipal Corporation of the State of Minnesota, to Include Certain Land Not Exceeding 200 Acres.

WHEREAS, The following described land is owned by the City of Willmar, Minnesota, and whereas the said property abuts upon the City and is so conditioned as to be properly subject to city government and since annexation thereof will be to the best interests of the City of Willmar and of the territory to be annexed,

NOW THEREFORE, Be It Ordained by the City Council of the City of Willmar, as follows:

Section 1. Annexation. The following described property is hereby annexed and included within the City of Willmar, Minnesota, as effectually as if it had originally been a part thereof:

That part of the NW $\frac{1}{4}$  of Sec. 23, T119N, R35W, described as follows:

Commencing at the NE corner of the NW $\frac{1}{4}$  of Sec. 23; thence 710' West along the north line of said NW $\frac{1}{4}$ ; thence south 760' along a line parallel to the East line of said NW $\frac{1}{4}$ ; thence west along a line parallel to the North line of said NW $\frac{1}{4}$  to a point on the east bank of Ditch 23-A, 1341' West of the East line of the said NW $\frac{1}{4}$ , which point is the point of beginning;

thence southeasterly along said east bank of Co. Ditch No. 23-A to a point on the south line of the said NW $\frac{1}{4}$  and 831' west of the Southeast corner of said NW $\frac{1}{4}$ ; thence westerly along the south line of said NW $\frac{1}{4}$  to the centerline of said Co. Ditch 23-A; thence Northwesterly along the centerline of said Ditch 23-A to a point 760' south of the north line of the said NW $\frac{1}{4}$ ; thence easterly along a line parallel with the north line of said NW $\frac{1}{4}$  to a point on the east bank of said Ditch 23-A, located 1341' west of the East line of said NW $\frac{1}{4}$  and which point is the point of beginning; said tract to contain 6.5 acres.

Section 2. Best Interests of City of Willmar. That the annexation will be to the best interests of the City of Willmar, Minnesota and of the territory affected.

Section 3. Abuts on City Limits. That the property above described abuts on the City Limits and is so conditioned as property to be subject to city government.

Section 4. Zoning. The area above described shall be zoned Farm Residence.

Section 5. Effective Date. This ordinance shall take effect and be in full force from and after filing a certificate hereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota and the Secretary of the State of Minnesota and from and after its passage and publication.

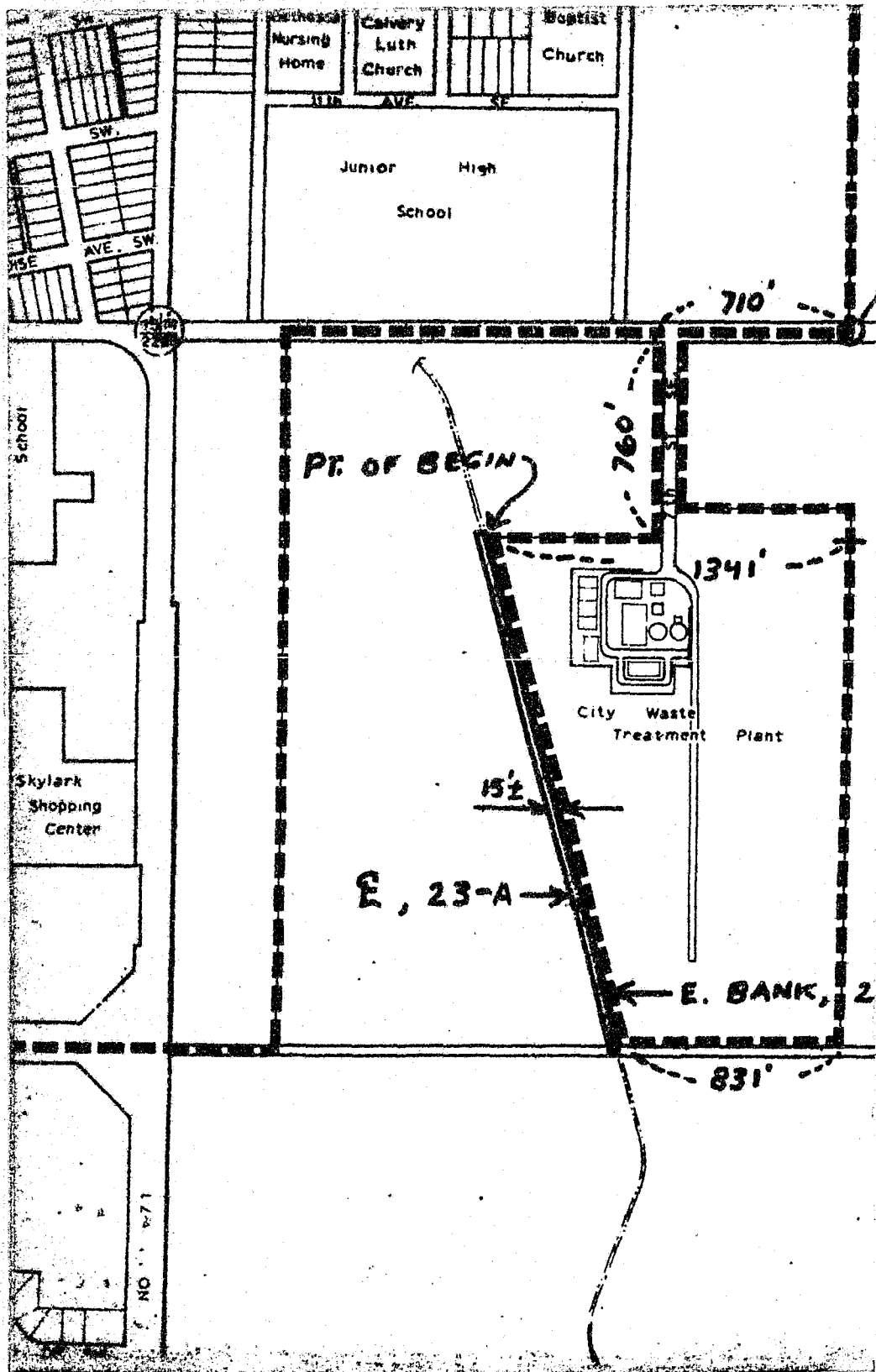
