AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF WASECA, MINNESOTA,
AND ESTABLISHING ZONING THEREOF:

WHEREAS the land hereinafter described is unplatted land of less than 200 acres situated in St. Mary's Township, Waseca County, Minnesota, and abuts upon the corporate boundary of the City of Waseca within the meaning of Minnesota Statutes Section 414.011, Chapter 1146 Laws of 1969; and

WHEREAS all of the owners of said land have petitioned the Council of the City of Waseca to have the land hereinafter described annexed to and included within the abutting City of Waseca; and

WHEREAS the Town Board of St. Mary's Township in said County and the Board of County Commissioners of Waseca County, Minnesota, have made and filed with said City their declarations that they have no objection to the annexation of said land to said City of Waseca; and

WHEREAS the Council of the City of Waseca has determined that the annexation of said land to said city will be to the best interests of said city and of the territory affected;

NOW THEREFORE, pursuant to the provisions of Minnesota Statutes Section 414.033, Subd. 5, Chapter 1146 Laws of 1969:

THE CITY OF WASECA DOES ORDAIN:

## SECTION I.

That there is hereby annexed to and included within the City of Waseca, Minnesota, the following described land in the County of Waseca and State of Minnesota, to-wit:

Beginning at a point on the South right of way line of County State Aid Highway No. 2, said point being 49.5 fook gouth of the Bouth 1/d countr of Section 12-107-23. Themse west along the South Cight of way line of County State Aid Highway No. 2, a distance of 704.3 feet to the West line of County State Aid Highway No. 77 extended, thence North parallel to the East line of the Southwest One-Quarter of Section 12-107-23, said line also being

the West line of County State Aid Highway No. 77, to the Southerly right-of-way line of the Chicago and Northwestern Railroad, thence Southeasterly along said Southerly right of way line of the railroad to its intersection with the North line of County State Aid Highway No. 2, thence East along the North right of way line of County State Aid Highway No. 2, to its intersection with the Southerly right of way line of U.S. Highway No. 14, thence Southeasterly along the Southerly right of way line of said U.S. Highway No. 14 to its intersection with the South right of way line of County State Aid Highway No. 2, thence West along the South line of County State Aid Highway No. 2, to the point of beginning.

#### SECTION II.

That said land is hereby zoned an industrial district within the meaning of the Zoning Ordinance of Waseca.

## SECTION III.

That a copy of this ordinance shall be filed with the Minnesota Municipal Commission, the Clerk of the St. Mary's Township Board, the Auditor and the Register of Deeds of the County of Waseca, and the Secretary of the State of Minnesota.

# SECTION IV.

That this Ordinance shall be effective ten days after its adoption and publication as provided by law.
