Dalglish— An ordinance amending Section 201.2 of the Charter of the City of Saint Paul; permitting the imposition of a tax upon food sales by restaurants, hotels, tourist courts, motels, trailer camps or similar facilities, or room charges by such facilities. The Council of the City of Saint Paul Does Ordain: SECTION 1

Pursuant to Minnesota Statutes 1967, Section 410,31, and upon the recommendation of the Charter Commission of the City of Saint Paul, the Charter of the City of Saint Paul, the Charter of the City of Saint Paul is hereby amended by adding to Section 201.2 thereof a new and unnumbered paragraph reading as follows:

"The prohibitions aforesaid with respect to sales taxes on food or rent shall not be construed to forbid such tax of no more than 3 per cent, in addition to the sales tax imposed by the State of Minnesota and any other taxes, upon food sales by restaurants, hotels, tourist courts, motels, trailer camps or similar facilities, or room charges by such facilities, as the Council shall by ordinance impose." SECTION 1 SECTION 2 This ordinance shall become effective ninety (90) days after passage, approval and publication, unless the effective date is delayed by the filing of a petition pursuant to law.
