ORDINANCE NO. 353

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HUTCHINSON AND ANNEXING THERETO CERTAIN LAND FORMERLY LOCATED IN THE TOWNSHIP OF DUNN

THE CITY OF HUTCHINSON DOES ORDAIN:

Section I. A petition has been filed with the governing body of the City of Hutchinson, Minnesota, by Earl M. and Loretta J. McDonald, being sole owners of the following described real property, to have said property annexed and included within the corporate limits of the City of Hutchinson, County of McLeod, State of Minnesota, to-wit:

A tract of land in the East Half of Section 2 T 116 N - R 30 W McLeod County described as follows:

Beginning at the NE corner of the SE 1/4 of Section 2; thence South along the East line of said Section 2, a distance of 33.0 feet; thence North $89^{\circ}-31'$ West, a distance of 150.00 feet; thence South, a distance of 550.0 feet; thence South $89^{\circ}+31'$ East, a distance of 150.00 feet; thence South, a distance of 66.00 feet; thence West a distance of 1700.0 feet; thence North, a distance of 150.00 feet; thence West a distance of 1000.00 feet; thence North a distance of 750.00 feet; thence East, a distance of 2700 feet more or less to the East line of said Section 2; thence South along the East line of said Section 2 a distance of 250 feet more or less to the point of beginning.


Section II. The quantity of land embraced within the foregoing description and bounded as described, is fifty and four -tenths (50.4) acres more or less.

Section III. The City Council hereby determines: (1) that the annexation will be to the best interests of the City of Hutchinson and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

Section IV. Therefore, the City of Hutchinson, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Hutchinson, Minnesota, as effectually as if it had originally been a part thereof.


Section V. This ordinance shall be final and shall take effect and be in force after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
