WHEREAS, a certain petition dated April 25, 1969, requesting annexation of the territory hereinafter described was duly presented to the Council on the 27th day of October, 1969; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 78.5 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all owners, and

WHEREAS, no objection to the annexation have been received from the Townboard, The County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the patition abuts upon the Northerly City Limits.

THE COUNCIL OF THE CITY OF ALBERT LEA MINNESOTA DOES ORDAIN:

Sec. 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected (2) that the territory described herein abuts upon the City Limits and is about to become urban or suburban in charachter; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Sec. 2. Territory Annexed: The corporate limits of the Gity are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Gity as effectually as if it had originally been a part thereof:

> The North half of the Southeast Quarter of Section 33, Township 103 North, Range 21 West of the 5th P.M. less couth 820.85' of the west 1316.4'

> > and

All that part of the Northwest Quarter of the Southwest Quarter of Section 34, Township 103 North, Range 21 West of the 5th P.M., lying and being westerly of the Chicago Rock Island & Pacific Railroad Company right-of-way.

Sec. 3. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Sec. 4. That the above property is hereby zoned as P Districts -Public facilities.

Sec. 5. Effective Date: The ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
