ORDINANCE NO. 1166

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY WHICH IS 75 PERCENT OR MORE BORDERED ON THREE SIDES BY THE CITY OF AUSTIN.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough, and

WHEREAS, this territory is 75 percent or more bordered on three sides by the City of Austin, and is deemed to be urban in character.

WHEREAS, the Common Council of the City of Austin served motice of intention upon the Board of Supervisors of Austin Township, Mower County, Minnesota on May 27, 1969,

AND WHEREAS, no objections to the ennexation have been received from the Town Board within the 60 day period as required by Chapter 414.03, Subdivision 2, Minnesota Statutes 1967:

THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1: The corporate limits of the City of Austin are hereby extended to include the umplatted land described as follows, and the same is hereby annexed to and included within the City of Austin as if it had originally been a part thereof:

- (1) All of Subdivision 3 of Outlot 4 in Section 9, Township 102 North, Range 18 West except the North 135 feet of said subdivision 3.
- (2) The south 224.5 feet of the East 353.48 feet of Outlot 4 in Section 9, Township 102 North, Range 18 West, excepting therefrom the South 104.5 feet.
- (3) All of Subdivision 2 of Outlot 4 in Section 9, Township 102 North, Range 18 West except the East 115 feet of the North 177 feet of said Subdivision 2.

SECTION 2: The City Recorder is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of the County in which the property is located, the Township Clerk of the Township in which the property is located, and the Minnesota Municipal Commission.

SECTION 3: This Ordinance takes effect upon passage and publication and filing certified copies as directed in Section 2.

AND WHEREAS, no objections to the annexation have been received from the Town Board within the 60 day period as required by Chapter 414.03, Subdivision 2, Minnesota Statutes 1967:
