ORDINANCE NO. 1173

EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED AND PLATTED LAND ABUTTING THE CITY OF AUSTIN LIMITS.

WHEREAS, a certain potition dated September 0, 1969, requesting ennexation of the territory described herein was duly presented to the Common Council on the 22nd day of September, 1969, and

WHEREAS, the cuantity of land embraced within the area described in the petition and bounded as described is approximately. It acres of unplatted land and .15 acres of platted land, no part of which is included within the limits of an incorporated city, village or borough, and

THEREAS, the potition was igned by all of the owners, and

WHEREAS, no objections to the amnexation have been received from the Town Board, the County Board or the governing body of any municipalities who boundary abut upon the land to be annexed.

WHEREAS, the land described hereinafter abute the City Limits on the north boundary thereof,

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1: The City Council hereby determines that the connexation will be to the best interest of the City and of the territory effected. That the territory described herein abuts the city limits and is urban or suburbon in character and that none of the said territory is now included within the limits of any city, village or borough.

SECTION 2: The corporate limits of the City of Austin are hereby extended to include the unplatted and platted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

Sub-Outlot 5 in the plat of Heald Subdivision, a subdivision of Outlot 9 in the Northeast Quarter of the Northwest Quarter of Section 4, Township 102 North, Range 18 West, Mower County, Minnesota and also beginning at a point 297 feet East and 708.8 feet North of the Southwest corner of the Cast half of the Northeast quarter of the Northwest guarter of Section 4, Township 102 North, Range 18 West; thence running East 54 feet; thence North 150 feet; thence West 54 feet; thence South 150 feet to the place of beginning.

SECTION 3: The City Recorder is hereby directed to file certified copies of this ordinance with the Minnesota Manicipal Commission, the Austin Township Clerk, the County Auditor and the Secretary of the State.
