EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED AND PLATTED LAND ADJUTING THE CITY OF AUSTIN LIMITS.

WHEREAS, a certain petition dated September 8, 1969, requesting annexation of the territory described herein was duly presented to the Common Council on the 22nd day of September, 1969, and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately .18 acres of unplatted land and .15 acres of platted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the petition was signed by all of the owners, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipalities who boundary abut upon the land to be annexed,

WHEREAS, the land described hereinafter abuts the City limits on the north boundary thereof,

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1: The City Council hereby determines that the annexation will be to the best interest of the City and of the territory effected. 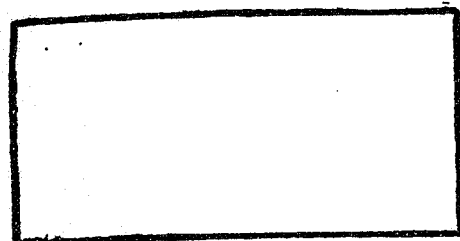
