ORDINANCE NO. 1182  
(AMENDING ORDINANCE NO. 1173)

AN AMENDED ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND ADJUTING THE CITY OF AUSTIN LIMITS.

WHEREAS, a certain petition dated September 2, 1969, requesting annexation of the territory described herein was duly presented to the Common Council on the 2nd day of September, 1969, and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 2 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the petition was signed by all of the owners, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipalities whose boundary abutt upon the land to be annexed,

WHEREAS, the land described hereinafter abuts the city limits on the south boundary thereof,

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1: The City Council hereby determines that the annexation will be to the best interest of the City and of the territory effected. That the territory described herein abuts the city limits and is urban or suburban in character and that none of the said territory is now included within the limits of any city, village or borough,

SECTION 2: The corporate limits of the City of Austin are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

All that part of the northeast quarter of the southwest quarter of Section 10, T10N, R16W, Meeker County, Minnesota lying north of the south bank of Turtle Creek as the same winds and flows, described as follows: Beginning at the southeast corner of the northwest quarter of said section 10, thence running west on said quarter line eleven rods, thence south to the south bank of Turtle Creek, thence southeasterly along the south bank of Turtle Creek to the east line of the southwest quarter of said section 10, thence north on the east line of said quarter to the place of beginning; Also all that part of the northeast quarter of the southeast quarter of Section 10, T10N, R16W lying north of the south bank of Turtle Creek and west of C.S.A.M. #23 centerline as used in crossing the bridge over Turtle Creek.

SECTION 3: The City Recorder is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Austin Township Clerk, the County Auditor and the Secretary of State.

SECTION 4: This ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.

ORDINANCE NO. 1172

**EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND ADJUTING THE CITY OF AUSTIN LIMITS.**

WHEREAS, a certain petition dated September 2, 1969, requesting annexation of the territory described herein was duly presented to the Common Council on the 2nd day of September, 1969, and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 2 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the petition was signed by all of the owners, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipalities who boundary abutt upon the land to be annexed,

WHEREAS, the land described hereinafter abuts the city limits on the south boundary thereof,

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1: The City Council hereby determines that the annexation will be to the best interest of the City and of the territory effected. That the territory described herein abuts the city limits and is urban or suburban in character and that none of the said territory is now included within the limits of any city, village or borough,

SECTION 2: The corporate limits of the City of Austin are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

All that part of the NE $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 10, Township 102, Range 18, lying north of turtle creek as the same winds and flows, described as follows; to-wit: beginning at the SE corner of the NW $\frac{1}{4}$  of said section 10, thence running west on said quarter line 11 rods, thence south to the north line of turtle creek, thence south on the east line and east on the north line of turtle creek to the east line of the southwest quarter of said Section 10, thence north on the east line of the SW $\frac{1}{4}$  of said Section 10, to place of beginning; also all that part of the NW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 10, in Township 102, Range 18, lying north of turtle creek and west of the Highway centerline as used in crossing the bridge over turtle creek, Mower County, Minnesota.

SECTION 3: The City Recorder is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Austin Township Clerk, the County Auditor and the Secretary of State.

SECTION 4: This ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.
