ONDINANCE NO. 1182 (AMENDING ORDINANCE NO. 1172)

AN AMENDED ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED UMPLATTED LAND ABUTTING THE CITY OF AUSTIN LIMITS.

WMEREAS, a cortain potition dated 8 ptember 2, 1969, requesting annexation of the territory described herein was duly presented to the Common Council on the 2nd day of September, 1969, and

WIENEAS, the cuentity of land embraced within the area described in the potition and bounded as described is approximately 2 acros of unplatted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHENEAS, the potition was signed by all of the owners, and

UMEREAS, no objections to the annoxation have been received from the Town Sourd, the County Heard or the governing body of any municipalities who boundary abutt upon the land to be annoxed,

WEREAS, the land described hereinafter ebuts the city limits on the south boundary thereof,

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN

SECTION 1: The City Council hereby determines that the enmozotion will be to the best interest of the City and of the territory effected. That the territory described herein abutta the city limits and is urben or suburban in character and that none of the said territory is now included within the limits of any city, village or borough.

SECTION 2: The corporate limits of the City of Austin are hereby extended to include the unpletted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

All that part of the northeast quarter of the southwest quarter of Section 10, Tiden, Albu, Mover County,
Minnesota lying morth of the south bonk of Turtle Creak
as the some winds and flows, described as follows:
Beginning at the southeast corner of the morthwest quarter
of soid section 10, thence running west on sold quarter
line eleven rods, thence south to the south bank of
Turtle Creek, thence southeasterly along the south bank
of Turtle Creek to the east line of the southwest quarter of sold section 10, thence north on the east line of
sold quarter to the place of beginning; Also all that
part of the northwest quarter of the southeast quarter
of Section 10, Tiden, Ridn lying north of the south bank
of Turtle Creek and west of C.S.A.H. \$23 centerline as
used in crossing the bridge over Turtle Creek.

SECTION B: The City Recorder is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Completion, the Austin Township Clerk, the County Auditor and the Secretary of State.

SECTION 4: This ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.

ORDINANCE NO. 1172

EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND ADUTTING THE CITY OF AUSTIN LIMITS.

WHEREAS, a certain petition dated September 2, 1969, requesting annexation of the tarritory described herein was duly presented to the Common Council on the 2nd day of September, 1969, and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 2 acres of implatted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the petition was signed by all of the owners, and

WHEREAS, no objections to the annuxation have been received from the Town Board, the County Board or the governing body of any municipalities who boundary abuttupon the land to be annexed,

WHEREAS, the land described horeinafter abuts the city limits on the south boundary thereof,

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1: The City Council hereby determines that the annexation will be to the best interest of the City and of the territory effected. That the territory described herein abutto the city limits and is urban or suburban in character and that none of the said territory is now included within the limits of any city, village or borough,

SECTION 2: The corporate limits of the City of Austin are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the oity as effectually as if it had originally been a part thereof:

All that part of the NE% of the SWA of Section 10. Township 102, Range 18, lying north of turtle creek as the same winds and flows, described as follows; towit: beginning at the SE corner of the NWA of said section 10, thence running west on said quarter line 11 rods, thence south to the north line of turtle creek, thence south on the east line and east on the north line of turtle creek to the east line of the southwest quarter of said Section 10, thence north on the east line of the SWA of said Section 10, to place of beginning; also all that part of the NWA of the SE% of Section 10, in Township 102, Range 18, lying north of turtle creek and west of the Highway centerline as used in crossing the bridge over turtle creek, Mower County, Minnesota.

SECTION 3: The City Recorder is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Austin Township Clerk, the County Auditor and the Secretary of State.

SECTION 4: This ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.
