ORDINANCE NO. 1183 (AMENDING ORDINANCE NO. 1174)

AN AMENDED ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CENTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ADUTTING THEPSON.

This property is owned by Mortin Arthur Busted and is located immodiately couth of 14th Avenue BV between 6th Street SV and 6th Street SV and 6th Street SV and 6th Street SV, in Section 13, Township 132 North, Range 18 Vest.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and

wiEREAS, this territory is completely surrounded on all sides by land already included within the comparate limits of the city and is deemed to be urban in character;

THE CORTON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAINS:

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORFORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

This property is owned by Martin Arthur Bustad and is located immediately south of 19th Avenue SW between 6th Street SW and 8th Street SW, and south of 19th Avenue SW between 4th Street SW and 6th Street SW, in Section 10, Township 10: North, Range 15 best.

WHETEAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and

WHEREAS, this territory is completely surrounded on all sides by land already included within the corporate limits of the city and is desmed to be urban in character;

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAINS:

SECTION 1: <u>Territory Annexed</u>. The corporate limits of the City of Austin, Minnesota, are hereby extended to include the territory described as follows, which territory now is and her heretofore been completely surrounded by territory already included within the city limits:

Commencing at the NE corner of the Sth, Section 10, Yourship 102 North, Range 18 best, Movor County, Minnesota, thence running west 181.5 feet on said quarter line to the point of beginning, thence south to the centerline of Turtle Crock, thence northwesterly slong the centerline of Turtle Creck to a point which is on the west line of Block 3. Rochford 2nd Addition to the City of Austin extended southerly, thence north along sold extended west line to the SW corner of Block 3, Rochford 2nd Addition, thence cost along the south line of said Block 3 to the SE corner of Block 3, Rochford 2nd Addition, this point also being on the west property line of 6th Street SW, thence south along the west property line of 6th Street 8W until it intersects the south line of Lot 1, Block 5, Rochford 2nd Addition outended westerly, thence east along the extension of the south line of Lot l. Block 5, Rochford 2nd Addition 561.50 foot to the west line of Lot 11, Block 5, of soid addition, thence south olong the extension of the west line of Lot 11, 164.30 fact to the north line of the SWE of soid Bootion 10, thence westerly 23.5 feet along the north line of said one quarter to the paint of beginning.
