ORDINANCE NO. 1183
(AMENDING ORDINANCE NO. 1170)

AN AMENDED ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ADJUTTING THEREON.

This property is owned by Martin Arthur Busted and is located immediately south of 14th Avenue SW between 6th Street SW and 8th Street SW and south of 15th Avenue SW between 4th Street SW and 6th Street SW, in Section 13, Township 132 North, Range 18 West.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and

WHEREAS, this territory is completely surrounded on all sides by land already included within the corporate limits of the city and is deemed to be urban in character;

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAINS:

SECTION 1: Territory Annexed. The corporate limits of the City of Austin, Minnesota, are hereby extended to include the territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Commencing at the NE corner of the SW $\frac{1}{4}$, Section 13, Township 132 North, Range 18 West, Mower County, Minnesota, thence running west 181.5 feet on said quarter line to the point of beginning, thence south to the south bank of Turtle Creek, thence northwesterly along the south bank of Turtle Creek to a point which is on the west line of Block 2, Rochford 2nd Addition to the City of Austin extended southerly, thence north along said extended west line to the SW corner of Block 3, Rochford 2nd Addition, thence east along the south line of said Block 3 to the SE corner of Block 4, Rochford 2nd Addition, this point also being on the west property line of 6th Street SW, thence south along the west property line of 6th Street SW until it intersects the south line of lot 1, Block 5, Rochford 2nd Addition extended westerly, thence east along the extension of the south line of Lot 1, Block 5, Rochford 2nd Addition 581.53 feet to the west line of Lot 11, Block 5, of said addition, thence south along the extension of the west line of Lot 11, 164.53 feet to the north line of the SW $\frac{1}{4}$ of said Section 13, thence westerly 25.5 feet along the north line of said one quarter to the point of beginning.

SECTION 2: Filing. The City Recorder is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the County in which the property is located, the Town Clerk of Austin Township, and the Minnesota Municipal Commission.

SECTION 3: Effective date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ADJUTING THEREON.

This property is owned by Martin Arthur Busted and is located immediately south of 14th Avenue SW between 6th Street SW and 8th Street SW and south of 13th Avenue SW between 4th Street SW and 6th Street SW, in Section 10, Township 102 North, Range 10 West.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and

WHEREAS, this territory is completely surrounded on all sides by land already included within the corporate limits of the city and is deemed to be urban in character;

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAINS:

SECTION 1: Territory Annexed. The corporate limits of the City of Austin, Minnesota, are hereby extended to include the territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Commencing at the NE corner of the SW $\frac{1}{4}$, Section 10, Township 102 North, Range 10 West, Nowor County, Minnesota, thence running west 181.5 feet on said quarter line to the point of beginning, thence south to the centerline of Turtle Creek, thence northwesterly along the centerline of Turtle Creek to a point which is on the west line of Block 3, Rochford 2nd Addition to the City of Austin extended southerly, thence north along said extended west line to the SW corner of Block 3, Rochford 2nd Addition, thence east along the south line of said Block 3 to the SE corner of Block 3, Rochford 2nd Addition, this point also being on the west property line of 6th Street SW, thence south along the west property line of 6th Street SW until it intersects the south line of Lot 1, Block 5, Rochford 2nd Addition extended westerly, thence east along the extension of the south line of Lot 1, Block 5, Rochford 2nd Addition 561.50 feet to the west line of Lot 11, Block 5, of said addition, thence south along the extension of the west line of Lot 11, 164.50 feet to the north line of the SW $\frac{1}{4}$ of said Section 10, thence westerly 23.5 feet along the north line of said one quarter to the point of beginning.

SECTION 2: Filing. The City Recorder is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the County in which the property is located, the Town Clerk of Austin Township, and the Minnesota Municipal Commission.

SECTION 3: Effective date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.
