ORDINANCE NO. 348

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE  
CITY OF THIEF RIVER FALLS

The City Council of the City of Thief River Falls do  
hereby ordain as follows:

Section 1.

WHEREAS the following described property situated in  
the County of Pennington and State of Minnesota, to-wit:

A parcel of land which is part of Gov't. Lot  
4, Section 27, T.154N, R.43W bounded as follows:

Beginning at the northwest corner of Block  
1 of Riverside Addition to Thief River Falls;  
thence Easterly along the North line of said  
Block 1 a distance of 120'; thence North a  
distance of 75' to the point of beginning of  
the described parcel; thence continuing North  
a distance of 75'; thence East along a line  
parallel with the North line of said Block 1  
to the centerline of the Thief River; thence  
South along the centerline of said River to  
a point; thence West along a line parallel to  
and 75' North of the North line of said Block  
1 to the point of beginning; containing 0.6  
acres more or less,

is completely surrounded by land within the municipal limits.

NOW, THEREFORE, pursuant to M.S.A. 414.033, Subd. 4 the  
above described property is hereby declared to be incorporated  
within and annexed to the City of Thief River Falls, Minnesota.

Section 2.

This ordinance shall be in force and effect from and  
after its passage, approval, publication and filing with the  
Municipal Commission, the Pennington County Auditor and the  
Secretary of State of the State of Minnesota.

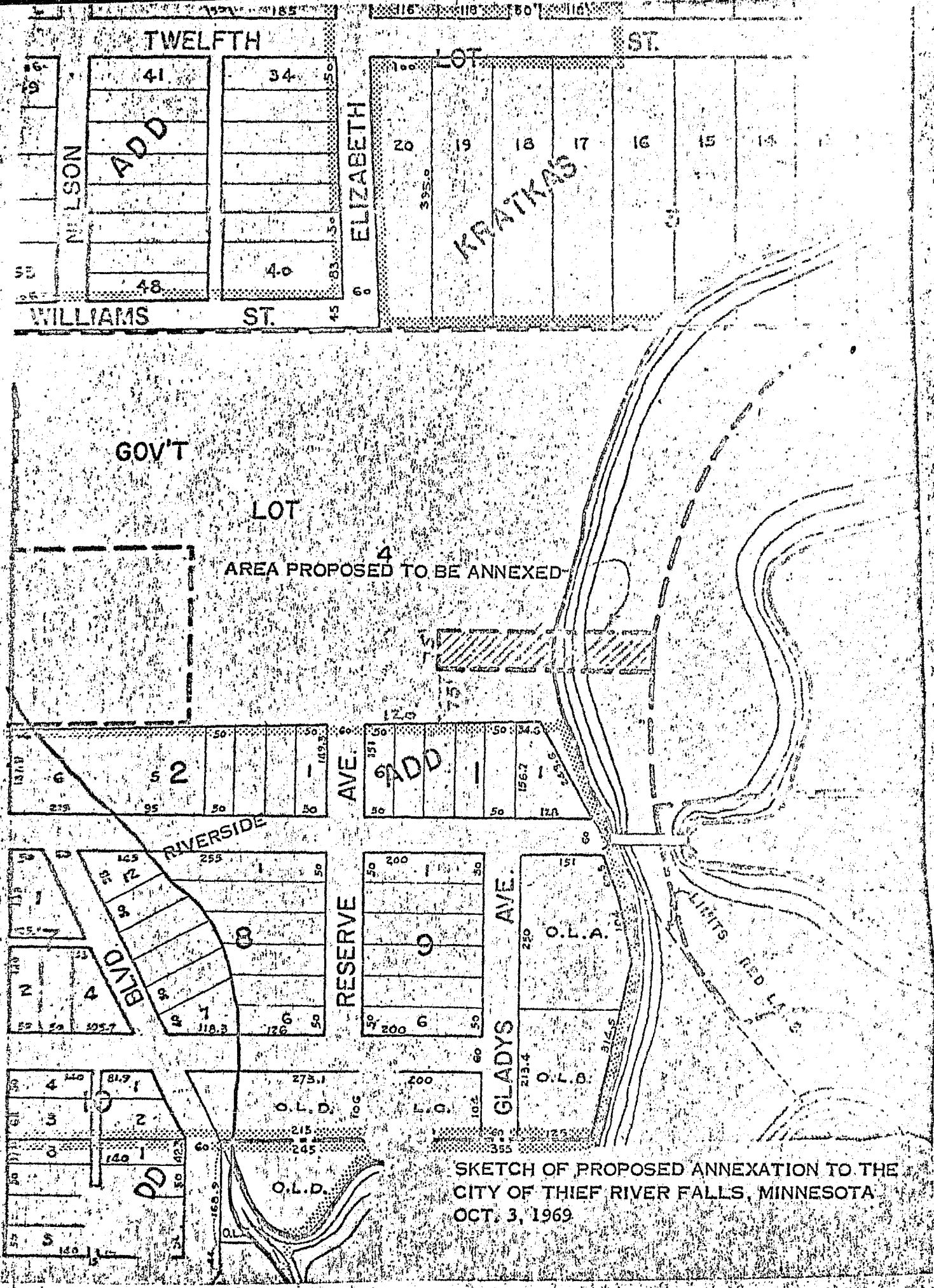
