AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF ROSEAU
TO INCLUDE CERTAIN UNINCORPORATED PLANTED AND UNPLANTED AND NOT
INCORPORATED SOIL AREAS IN ADDITION UPON THE VILLAGE LIMIT.

WHEREAS, certain petitions requesting annexation of the territory hereinabove described was duly presented to the council on the 28th day of October, 1909; and

WHEREAS the quantity of land embraced within the area described as the petition and bounded as described is 98 3/4 acres of platted and unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all citizens; and
WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the village limits at the east, north and west boundaries thereof;

The council of the Village of Roseau, Minnesota, ordains:

Section 1. The village council hereby determines (1) that the corporation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the village limits and is or is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the platted and unplatted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

TRACT 1.

Commencing at the point of intersection of the boundary boundary of Roseau County Highway No. 124 and the Southwesterly boundary of State Trunk Highway No. 11 as presently located and established, being the point of beginning, thence east on and along the Southwesterly boundary of State Trunk Highway No. 11 a distance of 550 feet; thence South at right angles a distance of 396 feet; thence west at right angles a distance of 396 feet to the Easterly right of the line of Roseau County Highway No. 124; thence North on and along the East right of way line of Roseau County Highway No. 124, a distance of 396 feet to the point of beginning, the same being a part of Government Lot No. 1, Section 19, Township 162 North, Range 39 West, according to the U. S. Government Survey thereof, Roseau County, Minnesota, and containing Five Acres more or less.

TRACT 2.

Beginning at the Southeast (SE) corner of the NW of the SE^{1/4} of Section 13, in Township 162 North, of Range 40 West, thence 25 feet along the South line of said NW of the SE^{1/4}, 791.84 feet; thence North parallel with the East line of said Northwest Quarter of the Southeast Quarter, 25 feet, whose point to be designated as the point of beginning of the tract of land hereby intended to be described; from this point of beginning run West 25 feet distant from and parallel to the South line of said Northwest Quarter of the Southeast Quarter, 139 feet; thence North parallel with the East line of said NW of the SE^{1/4}, 360 feet; thence East parallel with the South line of said NW of the SE^{1/4}, 139 feet to the West line of a tract of land heretofore conveyed to Anton Hildahl; thence South along the West line of said tract of land conveyed to Anton Hildahl 160 feet to the place of beginning, being a part of the NW of the SE^{1/4} of Section 13, in Township 162 North, Range 40 West, containing .416 acres, more or less, excepting and reserving, however, an easement on the Easterly 25 foot of said land for street purposes.

TRACT 3.

The West 150 feet of the East 166 $\frac{2}{3}$ foot of Riverdale Subdivision "a" and the West 150 feet of the East 166 $\frac{2}{3}$ foot of the South Half of Riverdale Subdivision "b".

Except the South 25 feet of said Riverdale Subdivision "a" and except that part of Riverdale Subdivision "b" of the NW of the SW^{1/4}, Section 13, Township 162 North, Range 40 West, according to the Plat thereof, described as follows:

Commencing at a point 25 feet North of the South line of said Northeast Quarter of the Southeast Quarter and one hundred feet of the East line of said Northeast Quarter of the Southwest Quarter; thence North, parallel with the East line of said Northeast Quarter of the Southwest Quarter, a distance of 160 feet; thence at right angles West a distance of 75 feet; thence at right angles South a distance of 160 feet, to a point 25 feet North of the South line of said NW of the SW^{1/4}, thence East parallel with said South line of said Northeast Quarter of the Southwest Quarter, a distance of 75 feet to the point of beginning, all according to the recorded plat thereof on file and of record in the office of the Register of Deeds in and for Roseau County, Minnesota.

TRACT 4.

The East 200 feet of the North Half of Subdivision "b" of Riverdale Subdivision in the Northwest Quarter of the Southwest Quarter, of Section 13, in Township 162 North, Range 40 West, according to the recorded plat thereof on file and of record in the office of the Register of Deeds in and for Roseau County, Minnesota;

TRACT 5.

Commencing at the Northwest corner of Lot 1, of Block 1 in Row's Addition to the Village of Roseau, according to the recorded plat thereof; thence North, parallel with the West line of the NW of the SE^{1/4} of Section 13, in Township 162 North, Range 40 West, a distance of 165 feet; thence East, parallel with the South line of said NW of the SE^{1/4}, a distance of 200 feet; thence South a distance of 165 feet, to the Northwest corner of Lot 2 of Block 1, of said Row's Addition to the Village of Roseau; thence West, on and along the North line of said Lot 1 and 2 a distance of 200 feet to the point of beginning, being a part of said Northwest Quarter of the Southwest Quarter of Section 13, in Township 162 North, Range 40 West, containing .75 acres more or less, all according to the U. S. Government Survey thereof, Roseau County, Minnesota.

TRACT 6.

The Southeast Quarter of the Northeast Quarter of the South-east Quarter (SE₂ NE₂, SE₄), of Section Fourteen (14), in Township One Hundred Sixty-two (162) North, Range Forty (40) West, according to the U. S. Government Survey thereof, Rococo County, Minnesota, and subject to highway easements of record.

TRACT 7.

The Southerly 207 feet of Lot One (1), Auditor's List No. Thirty-five (35), of the Southeast Quarter of the Northeast Quarter (SE₂ NE₂, SE₄), Section Fourteen (14), Township One Hundred Sixty-two (162) North, Range Forty (40) West, Rococo County, Minnesota.

TRACT 8.

Beginning at a point in the South line of the Southeast Quarter of the Southeast Quarter (SE₂ NE₂, SE₄) in Section 14, in Township 162 North, Range 40 West, 307 foot West of the Southeast corner of said section; thence west along said South line of said Section 310 feet; thence Northerly at an angle of 90°21' from the last mentioned line 337 feet; thence East parallel with the said South line of said section 310 feet, at an angle of 89°29'; thence Southerly at an angle of 90°21' 337 foot to the point of beginning, being a part of the SE₂ of the SE₄ of Section 14, Township 162 North, Range 40 West, Rococo County, Minnesota, containing 2.43 acres, more or less, subject to easements of record.

TRACT 9.

That part of the North half of the Northeast Quarter of Section Twenty-three (23), in Township 162 North, of Range 40 West, according to the U. S. Government Survey thereof, Rococo County, Minnesota, described as follows:

Commencing at the Northwest corner of the Northeast Quarter of the Northeast Quarter (SE₂ NE₂, SE₄), of Section Twenty-three (23), in Township One Hundred Sixty-two (162) North, Range Forty (40) West, thence in a Northerly direction along the North line of the NW of the SE₄ for a distance of 1,374.0 feet; thence at right angles South and parallel to the East line of said Northeast Quarter of the Northeast Quarter, a distance of 189 feet to the point of beginning of the tract of land to be runned;

Thence continuing South for a distance of 1,216.29 feet to the North line of the Great Northern Railway right-of-way; thence West at right angles along said North line of the Great Northern Railway right-of-way for a distance of 717.18 feet; thence at right angles North and parallel to the East line of the Northeast Quarter of the Northeast Quarter for a distance of 1,216.29 feet, to a point 50 feet South of the right-of-way line of the Minnesota State Trunk Highway No. 11; thence at right angles East, parallel to said South right-of-way line of Minnesota Trunk Highway No. 11, for a distance of 717.18 feet to the point of beginning, containing 26 acres more or less, all according to the U. S. Government Survey thereof, Rococo County, Minnesota.

TRACT 10.

That part of the North half of the Northeast Quarter of Section 23, in Township One Hundred Sixty-two (162) North, Range Forty (40) West, according to the U. S. Government Survey thereof, Rococo County, Minnesota, described as follows:

Commencing at the Northeast corner of the Northeast Quarter of the Northeast Quarter of Section 23, in Township 162 North, Range 40 West, thence in a westerly direction along the north line of the Northeast Quarter of the Northeast Quarter, for a distance of 330 feet; thence at right angles south and parallel to the east line of said Northeast Quarter of the Northeast Quarter, a distance of 125 feet to the point of beginning of the tract of land to be annexed;

Thence continuing south for a distance of 1,164.75 foot to the North line of the Great Northern Railway right of way; thence West at right angles along said North line of the Great Northern Railway right of way for a distance of 479.5 feet; thence at right angles South for a distance of 50 feet to the North line of the Great Northern Railway right of way; thence at right angles West for a distance of 257.5 feet; thence at right angles North and parallel to the East line of the Northeast Quarter of the Northeast Quarter for a distance of 1,214.75 feet, to a point 50 feet South of the South right of way line of Minnesota Trunk Highway No. 11; thence at right angles East parallel to said South right of way line of Minnesota Trunk Highway No. 11, for a distance of 736.8 feet to the point of beginning, containing 20 acres, more or less, but excepting therefrom the East 16 $\frac{1}{2}$ feet for road purposes;

and

The South 7 $\frac{1}{2}$ by (50) feet of the North 125 feet of the North Half of the Northeast Quarter of Section 23, Township 162 North, Range 40 West, except the East 330 foot thereof and excepting the West 1,059.8 feet thereof, all according to the U. S. Government Survey thereof, Roseau County, Minnesota.

TRACT 111.

The Southeast Quarter of the Northeast Quarter, and the East 35 feet of the Southwest Quarter of the Northeast Quarter, of Section 23, Township 162 North, Range 40 West, excepting therefrom the right of way of the Great Northern Railway, also excepting the right of way of Trunk Highway No. 89, and excepting therefrom the following described tracts, to-wit:

Commencing at a point 1,062 feet West of the Southeast corner of said Northeast Quarter, thence running north and parallel to the East Boundary of Section 23, for a distance of 300 feet, then running west and parallel to the North boundary for a distance of 300 feet; thence South parallel to the East boundary of Section 23 for a distance of 300 feet; thence running East along the Quarter line for 200 feet to the point of beginning.

And also excepting therefrom the following described property, to-wit:

Commencing at the point of intersection of the southerly right of way line of the Great Northern Railway with the westerly right of way line of State Trunk Highway No. 89, both as presently located and established thence westerly on and along said southerly right of way line of the Great Northern Railway, a distance of 616 feet; thence due South a distance of 312 feet; thence in an easterly direction parallel with the said southerly right of way line of the Great Northern Railway, to the said westerly right of way line of State Trunk Highway No. 89; thence North, on and along said westerly right of way line of State Trunk Highway No. 89, a distance of 212 feet, more or less, to the point of commencement, containing 2 acres, more or less.

Section 9. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Collection, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
