ORDINANCE NO. 60-05

AN ORDINANCE AMENDING TO THE VILLAGE OF WINSTED, MINNESOTA CERTAIN PLATTED AND UNPLATTED LANDS IN WINSTED TOWNSHIP ABUTTING AND LYING NORTHERLY OF LINNEM AVENUE EAST AND LOCATED IN THE SOUTH ONE-HALF OF THE NORTHEAST ONE-QUARTER (SE-1/4) OF SECTION 2, TOWNSHIP 117 NORTH, RANGE 27 WEST, MCLEOD COUNTY, MINNESOTA.

THE VILLAGE COUNCIL OF WINSTED DOES ORDAIN:

Section 1. All of the freeholders and owners of the lands hereinabove described, which lands abut upon the present territorial limits of the Village of Winsted, have petitioned the Mayor and Village Council of Winsted to annex such lands to, and to incorporate within, the Village of Winsted, McLeod County, Minnesota; and further, have petitioned said Mayor and Council to adopt an ordinance annexing such lands to the Village of Winsted. Such lands are located in Winsted Township, McLeod County, Minnesota, and are further described as follows:

Lots 1 through 9, "Moy's Shady Creek Drive Addition" according to the duly recorded plot thereof on file and of record in the office of the Register of Deeds in and for McLeod County, Minnesota;

Also, the following described tract to be platted as a separate Addition abutting "Moy's Shady Creek Drive Addition", further described as follows: Beginning at the Northwest corner of Lot 5, "Moy's Shady Creek Drive Addition"; thence due North for a distance of 50.00 feet; thence on a bearing of N50°01'E for a distance of 271.03 feet; thence on a bearing of S32°25'E for a distance of 164.00 feet; thence on a bearing of S57°35'W for a distance of 15.00 feet; thence on a bearing of S32°23'W for a distance of 114.85 feet; thence on a bearing of S57°35'W for a distance of 120.53 feet; to a point on the East line of Lot 9, "Moy's Shady Creek Drive Addition"; thence due North along the East line of said Lot 9 for a distance of 32.30 feet to the Northeast corner of said Lot 9; thence on a bearing of N69°29'W along the North line and the extension of the North line of said Lot 9 for a distance of 155.00 feet to the Southeast corner of Lot 5, "Moy's Shady Creek Drive Addition"; thence due North along the East line of said Lot 5 for a distance of 100.00 feet to the Northeast corner of said Lot 5; thence on a bearing of N69°29'W along the North line of said Lot 5 for a distance of 115.00 feet to the point of beginning. (being a part of the 1/2 of the NW 1/4 of section 2, Township 117 North, Range 27 West);

Section 3. The Mayor and Council of the Village of Winsted hereby determine that the lands described in Section 1, above situate upon the present territorial limits of the Village of Winsted, and are so conditioned as to be properly subjected to Village or Municipal Government, and the annexation of said lands will be in the best interests of the Village of Winsted and the land affected.

Section 4. Therefore, the lands described in Section 1, above are hereby annexed, added to and made a part of the Village of Winsted, Minnesota, as effectually as if it had originally been a part thereof.

Section 4. This Ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the McLeod County Auditor and the Secretary of State of the State of Minnesota.
