## ORDINANCE NO. 235

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINDOM TO INCLUDE APPROXI-MATELY TWO ACRES OF UNPLATTED LAND ABUT-TING UPON THE CITY LIMITS

WHEREAS, a certain petition dated Oct. 20, 1969 requesting annexation of the territory hereinafter described was duly presented to the Council on the 21st day of Oct., 1969; and

WHEREAS, the quantity of landembraced within the area described in the petition and bounded as described is approximately two acres of unplatted land, no part of which is included within or abuts the limits of any other incorporated city, village or borough; and

WHEREAS, the petition was signed by all of the owners of the described property; and

WHEREAS, copies of the said petition were duly filed with the Town Board of Great Bend Township and the County Board of Cottonwood County, being the Town and County in which all of the land proposed to be annexed is located, on Oct. 22, 1969; and

WHEREAS, under date of Nov. 3, 1969, the Town Board of Great Bend Township approved of said petition and elected not to exercise its right to enter objections to said annexation; and

WHEREAS, the land described in the petition abuts upon the city limits at a South and West boundary thereof;

BE IT ORDAINED BY THE CITY OF WINDOM, MINNESOTA AS FOLLOWS:

<u>SECTION 1:</u> The City Council hereby determines (1) that the annexation will be to the best interest of the City and to the territory affected; (2) that none of the territory is now included within or abuts the limits of any other city, village or borough.

<u>SECTION 2:</u> The corporate limits of the city are hereby extended to include the unplatted land hereinafter described and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof

<u>SECTION 3:</u> The description of the land located in the Township of Great Bend and Cottonwood County, Minnesota, which is hereby annexed is as follows, to-wit:

Part of the Northwest Quarter of the Northeast Quarter of Section 35, Township 105, Range 36, described as follows:

Beginning at the Northwest corner of Lot 1 in County Auditor's Subdivision No. 10 in the City of Windom and running thence West on and along the North line of said Section a distance of 551.4 feet; thence South a distance of 200 feet; thence East a distance of 551.4 feet to the Southwest corner of said Lot 1 in County Auditor's Subdivision No. 10; thence North on and along the West line of said lot a distance of 200 feet to the point of beginning.
