ORDINANCE NO. 236
AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF WINDOM TO INCLUDE APPROXIMATELY ONE HUNDRED ACRES OF UNPLATTED LAND
ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated Aug. 7, 1969 requesting annexation of the territory hereinafter described was duly presented to the Council on the 16th day of Sep. 1969; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately one hundred acres, no part of which is included in or abuts the limits of any other incorporated city, village or borcugh; and

WHEREAS, the petition was signed by nineteen owners, constituting a majority but not all of a total number of twenty five owners; and

WHEREAS, copies of the said petition were duly filed with the Town Board of Great Bend Township on Sep. 10, 1969 and on the County Board of Cottonwood County on Sep. 9, 1969, being the Town and County in which all of the land proposed to be annexed is located; and

WHEREAS, under date of Sep. 19, 1969, the Town Board of Great Bend Township approved of said petition and elected not to exercise its right to enter objections to said annexation; and

WHEREAS, a hearing on the proposed annexation was duly held by the City Council of the City of Windom after at least 30 days mailed notice to all of the property owners, and

WHEREAS, the land described in the petition abuts upon the city limits at the Northwesterly boundary thereof;

BE IT ORDAINED BY THE CITY OF WINDOM, MINNESOTA AS

SECTION 1: The City Council hereby determines (1) that the annexation will be to the best interest of the City and to the territory affected; (2) that none of the territory is now included within or abuts the limits of any other city, village or borough.

SECTION 2: The corporate limits of the city are hereby extended to include the unplatted land hereinafter described and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof.

SECTION 3: The description of the land located in the Township of Great Bend and Cottonwood County, Minn., which is hereby annexed is as follows, to-wit:

The Southwest Quarter of Section 23, Township 105, Range 36, except the part thereof which lies within the city limits of the City of Windom. All that part of the Northwest Quarter of Section 26, Township 105, Range 36 lying Easterly and Northerly of the center line of the Des Moines River, except the part thereof which lies within the city limits of the City of Windom Lot "K" of Ringkob and Pope's Addition to the City of Windom.

Adopted this 2nd day of Dec. 1969.
