ORDINANCE NO. 351
AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF THIEF RIVER FALLS

The City Council of the City of Thief River Falls do hereby ordain as follows:

Section 1.

WHEREAS the sole owner of the following described premises situated in the City of Thief River Falls, County of Pennington and State of Minnesota, to-wit:

All that part of Government Lot 4, Section 3 T.153 N., R. 43W. lying Easterly of the Easterly right of way line of the Minnespolis St. Paul and Sault Ste. Marie Railroad containing 23.0 acres more or less,

has petitioned the City Council to have such land included within the municipality and has filed copies of said petition with the Municipal Commission of the State of Minnesota, with the Town Board of the Township of North and with the County Board of the County of Pennington, State of Minnesota, and

WHEREAS the above described property abuts upon the boundaries of the City of Thief River Falls, and

WHEREAS no objections to the proposed annexation have been submitted,

NOW, THEREFORE, it is hereby determined that the annexation of said premises will be to the best interest of the City of Thief River Falls and of the territory affected and the above described premises are hereby declared annexed to the City of Thief River Falls.

Section 2.

This ordinance shall be in force and effect from and after its passage, approval, publication and filing with the Municipal Commission, the Town Board, the Pennington County Auditor and the Secretary of State of the State of Minnesota.




