# RESOLUTION

1-15-70

At a regular meeting of the City Council held January 27, 19 70  
Alderman Rambeck seconded by Alderman Wigness introduced the  
following resolution and moved its adoption:

ORDINANCE NO. 352  
AN ORDINANCE ANNEXING CERTAIN LANDS TO THE  
CITY OF THIEF RIVER FALLS

The City Council of the City of Thief River Falls do hereby ordain as follows:

Section 1.

WHEREAS all of the owners of the following described premises situated in the  
County of Pennington and State of Minnesota, to-wit:

A parcel of land which is part of Rustad's Subdivision and Sherwood Forest  
Addition bounded as follows:

Beginning at a point on the West line of Section 35, T.154N., R.43W.,  
which point lies 1139.1' South of the northwest corner of said Section 35;  
thence South 87 degrees 01'30" East a distance of 1100'; thence due South a  
distance of 66.089'; thence South 87 degrees 11'30" East a distance of  
622.26'; thence South 02 degrees 07'45" East a distance of 1019.895'; thence  
South 20 degrees 06'45" East a distance of 220.738'; thence South 14 degrees  
38'25" East to the centerline of the Red Lake River; thence meandering along  
the said centerline to an intersection with a line which lies 15' West of and  
parallel to the East line of Lot 56 of Rustad's Subdivision; thence Northerly  
along said line to the centerline of the East-West Cart Way in said Rustad's  
Subdivision; thence Easterly along the centerline of said Cart Way to the East  
line of said Section 35; thence due South along said East line to the point  
of beginning, less Lots 7, 8, 9 and 10 of Block 1 of said Sherwood Forest  
Addition; containing 68 acres more or less,

have petitioned the City Council to have such land included within the municipality  
and have filed copies of said petition with the Municipal Commission of the State of  
Minnesota, with the Town Board of the Township of North and with the County Board of  
the County of Pennington, State of Minnesota, and

WHEREAS the above described property abuts upon the boundaries of the City of  
Thief River Falls, and

WHEREAS no objections to the proposed annexation have been submitted,

NOW, THEREFORE, it is hereby determined that the annexation of said premises  
will be to the best interest of the City of Thief River Falls and of the territory  
affected and the above described premises are hereby declared annexed to the City of  
Thief River Falls.

Section 2.

This ordinance shall be in force and effect from and after its passage,  
approval, publication and filing with the Municipal Commission, the Pennington County  
Auditor and the Secretary of State of the State of Minnesota.




