## RESOLUTION No. 1-16-70

At a <u>regular</u> meeting of the City Council held <u>January 27</u>, 1970. Alderman <u>Engelstad</u> seconded by Alderman <u>Froiland</u> introduced the

following resolution and moved its adoption:

ORDINANCE NO. 353 AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF THIEF RIVER FALLS

This ordinance shall be in force and effect from and after its passage, approval, publication and filing with the Municipal Commission, the Pennington County Auditor and the Secretary of State of the State of Minnesota.
