# RESOLUTION

No. 1-16-70

At a regular meeting of the City Council held January 27, 19 70.

Alderman Engelstad seconded by Alderman Froiland introduced the following resolution and moved its adoption:

ORDINANCE NO. 353  
AN ORDINANCE ANNEXING CERTAIN LANDS TO THE  
CITY OF THIEF RIVER FALLS

The City Council of the City of Thief River Falls do hereby ordain as follows:

Section 1.

WHEREAS all of the owners of the following described premises situated in the County of Pennington and State of Minnesota, to-wit:

A portion of the NW $\frac{1}{4}$  NW $\frac{1}{4}$ , Sec. 35, T.154N, R.43W described as follows:

Beginning at a point on the West line of said Section 35, T.154N, R.43W said point being 739.1 feet south of the northwest corner of said Section 35; thence S. 87 degrees 01'30" E. a distance of 266 feet; thence south 400'; thence N. 87 degrees 01'30" W a distance of 266 feet; thence north along the west line of said Section 35 a distance of 400' to the point of beginning; containing 2.4 acres more or less, and

That part of Government Lot 7 in Sec. 34, T.154N, R.43W described as follows:

Beginning at a point on the centerline of the East-West Cart Way and the westerly property line of Lot 52, Rustad's Subdivision extended; thence easterly along the centerline of the said East-West Cart Way a distance of 100'; thence southerly along the easterly property line of said Lot 52 to the centerline of the Red Lake River; thence westerly along the centerline of the Red Lake River to an intersection with the westerly property line of Lot 52 extended; thence northerly along the westerly line of Lot 52, Rustad's Subdivision to the point of beginning on the centerline of the East-West Cart Way; containing 2 acres more or less,

have petitioned the City Council to have such land included within the municipality and have filed copies of said petition with the Municipal Commission of the State of Minnesota, with the Town Board of the Township of North and with the County Board of the County of Pennington, State of Minnesota, and

WHEREAS the above described property abuts upon the boundaries of the City of Thief River Falls, and

WHEREAS no objections to the proposed annexation have been submitted,

NOW, THEREFORE, It is hereby determined that the annexation of said premises will be to the best interest of the City of Thief River Falls and of the territory affected and the above described premises are hereby declared annexed to the City of Thief River Falls.

Section 2.

This ordinance shall be in force and effect from and after its passage, approval, publication and filing with the Municipal Commission, the Pennington County Auditor and the Secretary of State of the State of Minnesota.


