ORDINANCE NO. 1105

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below to not presently included within the corporate limits of any incorporated city, village or borough;

WIEREAS, this territory is completely surrounded on all sides by land already included within the corporate limits of the city and is deemed to be urben in character;

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAINS:

SECTION 1: Territory emexed. The corporate limits of the City of Austin, Minnesta, are hereby extended to include the territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

- (1) Beginning of the northwest corner of the southeast quarter, Section 1, Township 102 North, Range 18 West, Mower County, Minnesota, this point also being on the west right-of-way line of T.H. 218, thence south along the west right-of-way line of said trunk highway a distance of 369 feet to the centerline of lat Avonue SE, thence easterly along the extension of the centerline of lat Avonue SE until this line intersects the east right-of-way line of said trunk highway, thence north along the east line of said trunk highway until it intersects the north line of said quarter section, thence west along this north line of said quarter section to the point of beginning.
- (2) Commencing at the northeast corner of the southeast quarter of the southwest quarter of Section 35. Township 133 North. Range 18 West, Mower County, Minnesota, thence westerly along the north line of said one quarter one quarter until it intersects the southerly right-of-way line of Pederal Mighway \$90, this point being the point of beginning, thence morthwesterly along the southerly right-of-way of said Federal Mighway \$90 to the east line of Crane's 2nd Addition to the City of Austin thence southerly along the east line of Crane 2nd Addition until it intersects the north line of said one quarter one quarter section, thence easterly along said north line to the place of beginning.
- (3) Commencing at the northwest corner of Block 1, in Sunland Addition, thence running west slong the south line of Oakland Avenue, 305.27 feet, thence south 303 feet, thence cast 396.27 feet to the southwest corner of said Block 1, thence north 303 feet to the point of beginning, located in the Ny of the SW4, Section 1, Township 102 North, Range 18 West, Mower County, Minnesota.

SECTION 2: <u>Filing</u>. The City Recorder is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the County in which the property is located, the Township Clerk of the Township in which the property is located, and the Minnesota Municipal Commission.

SECTION 3: Effective date of Annexation. This Ordinance takes effect upon puesage and publication and the filing of certified copies as directed in Section 2.


