ORDINANCE NO. 452

AN ORDINANCE ANNEXING
CERTAIN PROPERTY COM-
PLETELY SURROUNDED BY
LAND WITHIN THE MUNI-
CIPAL LIMITS OF THE CITY
OF ANOKA, TO THE CITY OF
ANOKA.

The Commission of the City
of Anoka do ordain as follows:

Section 1. A tract, piece and
parcel of land, completely sur-
rounded by land within the mun-
icipal limits of the City of Ano-
ka, Minnesota, and described
as follows, to-wit:

Commencing at the North-
west corner of Lot 5, Audi-
tor's Subdivision No. 32,
Anoka County, Minnesota;
thence proceeding South
along the West line of said
Lot 5, for a distance of two
hundred and fifteen (215)
feet; proceeding thence East
and parallel to the North
line of said Lot 5, for a dis-
tance of two hundred (200)
feet; proceeding thence
North and parallel to the
West line of said Lot 5 to the
North line thereof; proceed-
ing thence West along said
North line to the point of
commencement;

is hereby declared to be annexed
and to be an addition to the City
of Anoka.

Section 2. This Ordinance shall
be in full force and effect thirty
(30) days from the date of pub-
lication.
