ORDINANCE NO. 244

AN ORDINANCE EXTENDING THE CORPORATE LIMITS  
OF THE CITY OF STAPLES AND INCORPORATING  
ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples do ordain as follows:

Section 1. A petition has been filed with the governing body of the City of Staples, Minnesota by the owners of the following described tracts of real estate to have such tracts included within the City of Staples, Minnesota:

- Parcel 1. The south 200 feet of the west 1,087 feet of the Southeast Quarter of the Northwest Quarter of Section 36, Township 134, Range 33, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 2. The South 200 feet of the East 350 feet of the Northwest Quarter of the Northwest Quarter, Section 36, Township 134, Range 33 except that portion platted as Park Estates, including all streets, alleys and utility easements therein and abutting thereon.
- Parcel 3. Lot 1, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 4. Lot 2, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 5. Lot 3, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 6. Lot 4, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 7. Lot 5, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 8. Lot 6, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 9. Lot 7, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 10. Lot 8, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 11. Lot 9, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 12. Lot 10, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 13. Lot 11, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 14. Lot 12, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.

- Parcel 15. Lot 13, Block 1, Park Estates, including all street, utility easements and alleys therein and abutting thereon.
- Parcel 16. Lot 14, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 17. Lot 15, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 18. Lot 16, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 19. Lot 17, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 20. Lot 18, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 21. Lot 19, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 22. Lot 20, Block 1, Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 23. Lot 1, Block 2, First Addition to Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 24. Lot 2, Block 2, First Addition to Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 25. Lot 3, Block 2, First Addition to Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 26. Lot 4, Block 2, First Addition to Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 27. Lot 5, Block 2, First Addition to Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 28. Lot 6, Block 2, First Addition to Park Estates, including all streets, utility easements and alleys therein and abutting thereon.
- Parcel 29. Lot 7, Block 2, First Addition to Park Estates, including all streets, utility easements and alley therein and abutting thereon.

Section 2. The quantity of land embraces within each of the foregoing described parcels and bounded as described is less than 200 acres.

Section 3. Notice of the filing of the petition has been filed with the Thomastown Town Board, County Auditor of Wadena County and with the Minnesota Municipal Commission at least 30 days prior to the first reading of this ordinance.

Section 4. All fees required to be paid by the petitioners have been duly paid.

Section 5. The City Council hereby determines that the annexation will be to the best interests of the City of Staples, Minnesota, and of the territory affected; that the territory described herein abuts upon the city and is so conditioned as property to be subjected to City Government.

Section 6. Therefore, the City of Staples, Minnesota hereby ordains and declares that the property herein before described by and the same is hereby annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.

Section 7. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
