AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF EMMONS TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND AND UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, A CERTAIN PETITION DATED MARCH 16, 1970, REQUESTING ANNEXATION OF THE TERRITORY HEREINAFTER DESCRIBED WAS DULY PRESENTED TO THE COUNCIL ON THE 16TH DAY OF MARCH, 1970; AND

WHEREAS, THE QUANTITY OF LAND ENBRACED IN THE AREA DESCRIBED IN THE PETITION AND BOUNDED AS DESCRIBED IS 120 ACRES OF PLATTED AND UNPLATTED LAND, NO PART OF WHICH IS INCLUDED WITHIN THE LIMITS OF AN INCORPORATED CITY, VILLAGE OR BOROUGH; AND

WHEREAS, THE PETITION WAS SIGNED BY ALL OF THE OWNERS;
AND

WHEREAS, NO OBJECTIONS TO THE ANNEXATION HAVE BEEN RECEIVED FROM THE TOWN BOARD, THE COUNTY BOARD, OR THE GOVERNING BODY OF ANY MUNICIPALITY WHOSE BOUNDARIES ABUTT UPON THE BOUNDARIES OF THE LAND TO BE ANNEKED; AND

WHEREAS, THE LAND DESCRIBED IN THE PETITION ABUTTS UPON THE VILLAGE LIMITS AT THE NORTH BOUNDARY THEREOF;

THE COUNCIL OF THE VILLAGE OF EMMONS, MINNESOTA, ORDAINS:

SECTION 1. THE VILLAGE COUNCIL HEREBY DETERMINES (1) THAT THE ANNEXATION WILL BE TO THE BEST INTERESTS OF THE VILLAGE AND OF THE TERRITORY AFFECTED; (2) THAT THE TERRITORY DESCRIBED HEREIN ABUTTS UPON THE VILLAGE LIMITS AND IS ABOUT TO BECOME URBAN OR SUBURBAN IN CHARACTER; AND (3) THAT NONE OF SAID TERRITORY IS NOW INCLUDED WITHIN THE LIMITS OF ANY CITY, VILLAGE OR BOROUGH.

SECTION 2. TERRITORY ANNEXED. THE CORPORATE LIMITS OF THE VILLAGE ARE HEREBY EXTENDED TO INCLUDE THE PLATTED AND UNPLATTED LAND DESCRIBED AS FOLLOWS, AND THE SAME IS HEREBY ANNEXED TO AND INCLUDED WITHIN THE VILLAGE AS EFFECTUALLY AS IF IT HAD ORIGINALLY BEEN A PART THEREOF:

ALL THAT PORTION OF GOVERNMENT LOT 2 IN SECTION 33, TOWNSHIP 101 NORTH OF RANGE 22 WEST OF THE 5TH P. M., LESS GOLD TO THE MINNEAPOLIS AND ST. LOUIS RAILWAY COMPANY FOR RIGHT-OF-WAY, AND LESS THAT PART OF SAID LOT HERETOFORE CONVEYED TO HENRY H. EMMONS BY WARRANTY DEED IN BOOK 36 OF DEEDS, PAGE 322, WHICH LIES EAST OF THE RIGHT-OF-WAY OF U. S. HIGHWAY NO. 69. AND

THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 28; AND

GOVERNMENT LOT 2 AND THAT PART OF GOVERNMENT LOT 1 LYING EAST AND SOUTH OF THE RAILROAD RIGHT-OF-WAY IN SECTION 28; AND

GOVERNMENT LOT 1 IN SECTION 33;

ALL IN TOWNSHIP 101 NORTH, RANGE 22 WEST OF THE 5TH P. M., LESS AND EXCEPTING A PORTION OF SAID GOVERNMENT LOT 1 DESCRIBED AS LOTS 1, 2, 3, 4, 5, 6, 7, 8, 9, AND 10, ARROWHEAD FIRST SUBDIVISION, FREEBORN COUNTY, MINNESOTA; AND

LOTS 1, 2, 3, 4, 5, 6, 7, 8, 9, AND 10, ARROWHEAD FIRST SUBDIVISION, FREEBORN COUNTY, MINNESOTA.

SECTION 3. FILING. THE VILLAGE CLERK IS HEREBY DIRECTED TO FILE CERTIFIED COPIES OF THIS ORDINANCE WITH THE MINNESOTA MUNICIPAL COMMISSION, THE SECRETARY OF STATE, AND THE FREEBORN COUNTY AUDITOR.

SECTION 4. EFFECTIVE DATE. THIS ORDINANCE SHALL TAKE EFFECT UPON ITS PASSAGE AND PUBLICATION.
