ORDINANCE NO. 333

AN ORDINANCE FOR THE ANNEXATION OF CERTAIN LANDS INTO THE CITY OF ORTONVILLE, MINNESOTA

The City Council of the City of Ortonville, Minnesota, does ordain:

Section 1. That the following described premises abutting the Municipal corporate limits of the City of Ortonville, Minnesota, be and are hereby annexed and brought within the corporate limits of the City of Ortonville, Minnesota, to-wit:

> Outlot Two (2) of Government Lot Four (4), in Section Five (5), Township One Hundred Twenty-one (121) North, Range Forty-six (46) West, Big Stone County, Minnesota.

Section 2. This Ordinance shall be in force and effect from and after its passage and publication according to law.
