AN ORDINANCE OF THE CITY COUNCIL OF OTTOVILLE, MINNESOTA, TO AMEND CHAPTER 317, STATUTES OF MINNESOTA, RELATIVE TO THE CITY OF OTTOVILLE, MINNESOTA.

The City Council of the City of Ottoville, Minnesota, hereby enacts:

Section 1. That the following parcels of land abutting the municipal corporate limits of the City of Ottoville, Minnesota, be and are hereby annexed and brought within the corporate limits of the City of Ottoville, Minnesota, to-wit:

Outlet Three (3) of Government Lot Four (4) 2^d section, five (5), Township One Hundred Twenty-one (121) North, Range Forty-six (46) West, Big Lake County, Minnesota.

Section 2. This Ordinance shall be in force and effect from and after its passage and publication according to law.
