ORDINANCE NO. 239

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINDOM TO INCLUDE APPROXIMATELY 10.52 ACRES OF UNPLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated April 7, 1970 requesting annexation of the territory hereinafter described was duly presented to the Council on the 7th day of April, 1970; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 10.52 acres of unplatted land, no part of which is included within or abuts the limits of any other incorporated city, village or borough; and

WHEREAS, the petition was signed by all of the owners of the described property; and

WHEREAS, copies of the said petition were duly filed with the Town Board of Great Bend Township and the County Board of Cottonwood County, being the Town and County in which all of the land proposed to be annexed is located, on April 7, 1970; and

WHEREAS, under date of April 20, 1970, the Town Board of Great Bend Township approved of said petition and elected not to exercise its right to enter objections to said annexation; and

WHEREAS, the land described in the petition abuts upon the city limits at a North boundary thereof;

BE IT ORDAINED BY THE CITY OF WINDOM, MINNESOTA AS FOLLOWS:

SECTION 1: The City Council hereby determines (1) that the annexation will be to the best interest of the City and to the territory affected; (2) that none of the territory is now included within or abuts the limits of any other city, village or borough.

SECTION 2: The corporate limits of the city are hereby extended to include the unplatted land hereinafter described and the same is hereby annexed to an included within the city as effectually as if it had originally been a part thereof

SECTION 3: The description of the land located in the Township of Great Bend and Cottonwood County, Minnesota, which is hereby annexed is as follows, to wit:

Part of the East One-Half of the Southeast Quarter of Section 23, Township 105, Range 36 described as follows: Beginning at the Southeast corner of said Section 23 and running thence on and along the South line of said Section 23 a distance of 1307 feet to the Southwest corner of the Southeast Quarter of the Southeast Quarter of said Section 23; thence North on and along the West line of the Southeast Quarter of the Southeast Quarter of said Section 23 a distance of 345 feet; thence East on and along a line parallel with the South line of said Section 23 a distance of 947.84 feet; thence North 77.22' East a distance of 123.81 feet; thence South 88.38' East a distance of 239.36 feet to the East line of said Section 23; thence South on and along the East line of said Section 23 a distance of 366.94 feet to the point of beginning, containing 10.52 acres, more or less: together with all town roads abutting said property.
