AN ORDINANCE TO AMEND THE CHARTER OF THE CITY OF STAPLES, MINNESOTA, BY THE OWNERS OF THE FOLLOWING DESCRIBED REAL ESTATE TO HAVE SAID LAND INCLUDED WITHIN THE CITY OF STAPLES, MINNESOTA.

The City Council of the City of Staples so ordains as follows:

Section 1. A petition has been filed with the governing body of the City of Staples, Minnesota, by the owners of the following described real estate to have said land included within the City of Staples, Minnesota:

Tract No. 1. Commencing at the northwest corner of the Northeast quarter (1/4) of section one (1), Township one hundred thirty-three (133) North, Range thirty-three (33) west of the 5th T. R., thence south along the quarter line a distance of 787.6 feet to the point of beginning; thence west a distance of 55.5 feet, thence north a distance of 100 feet, thence east to said quarter line a distance of 55.5 feet to a point on said quarter line which is 100 feet north of the point of beginning, thence south to the point of beginning, including all streets and alleys abutting thereon and contained therein and utility easements.

Tract No. 2. Commencing at the northwest corner of the Northeast quarter (1/4) of section one (1), Township one hundred thirty-three (133) North, Range thirty-three (33) west, thence south along the quarter line a distance of 677.6 feet to the place of beginning; thence south along the said quarter line a distance of ten (10) feet; thence west a distance of 55.5 feet; thence south a distance of 100 feet; thence west to a point 100 feet east of the east line of sixth street extended; thence north a distance of 110 feet; thence east to the point of beginning, a distance of approximately 595.5 feet, including all streets and alleys abutting thereon and contained therein and utility easements.

Tract No. 3. Commencing at the northwest corner of the Northeast quarter (1/4) of section one (1), Township one hundred thirty-three (133) North of Range thirty-three (33) west, thence running south along the quarter line 687.6 feet and thence west for a distance of 545.5 feet, and with this latter point as a point of beginning for the land conveyed hereby; thence running north along the east line of said sixth street extended 100 feet; thence east 100 feet; thence south 100 feet; thence west 100 feet to the point of beginning, including all streets and alleys abutting thereon and contained therein and utility easements.

Section 2. The quantity of land embraced within the foregoing described parcels and bounded as described is less than three acres.

Section 3. Notice of the filing of the petition has been filed with the Staples Town Board, County Auditor of Lake County and with the Minnesota Municipal Commission at least 30 days prior to the first meeting of said ordinance.

Section 4. All fees required to be paid by the petitioners have been fully paid.

Section 5. The City Council hereby determines that the annexation will be in the best interests of the City of Staples, Minnesota, and of the territory affected; that the territory described herein vests upon the City and is so conditioned as properly to be subject to City Government.

Section 6. Therefore, the City of Staples, Minnesota hereby certifies and declares that the property hereinbefore described be and the same is hereby annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.

Section 7. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
