AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES AND INCORPORATING ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples do ordain as follows:

Section 1. A petition has been filed with the governing body of the City of Staples, Minnesota, by the owners of the following described real estate to have such land included within the City of Staples, Minnesota:

Lot Three (3), Block One (1), Pine Crest Addition, Wadena County, Minnesota, including all streets and alleys abutting thereon and contained therein and utility easements.

Section 2. The quantity of land embraced within the foregoing described parcels and bounded as described is less than one acre.

Section 3. Notice of the filing od the petition has been filed with the Thomastown Township Board, County Auditor of Wadena County and with the Minnesota Municipal Commission at least 30 days prior to the first reading of this ordinance.

Section 4. All fees required to be paid by the petitioners have been duly paid.

Section 5. The City Council hereby determines that the annexation will be to the best interests of the City of Staples, Minnesota, and of the Territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

Section 6. Therefore, the City of Staples, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in, the City of Staples, Minnesota, & effectually as if it had orginally been a part thereof.

Section 7. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Audotor and the Secretary of State, and from and after its passage and publication.
