ORDINANCE NUMBER 42

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF NEW GERMANY, CARVER COUNTY, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED LAND AND BRUSHING 200 ACRES IN AREA

Whereas, a certain petition dated April 13, 1970, requesting annexation of the territory described below was duly presented to the Council on the 13th day of April, 1970.

And Whereas it appears that the Township of Gordon, Carver County, Minnesota has waived the waiting period as set forth in Section 414.033 (Subd 5), Minnesota Statutes Annotated,

And Whereas it appears that said petition is proper in all respects,

Now, Therefore, the Council of the Village of New Germany, Carver County, Minnesota ordains as follows:

Section 1. It is hereby determined that the territory described below abuts upon the Village and is so conditioned as properly to be subjected to Village Government.

Section 2. The corporate limits of the Village of New Germany are hereby extended to include the following described premises lying and being in the County of Carver and State of Minnesota and described as follows, to-wit:

The North Half of the Southeast Quarter (1/2 of 3/4) excepting therefrom the East 414.5 feet thereof; Also the East Half of the Southwest Quarter (1/2 of 3/4) excepting therefrom the right of way of the Great Northern Railway Company, all of the above described tracts being in Section 5, Township 116, Range 26, and also excepting from the last described tract the West 732 feet of the South 330 feet thereof.

Section 3. The Village Clerk is hereby directed to file certified copies of this ordinance in the office of the Commission of Municipalities of the State of Minnesota, the Carver County Auditor, the Secretary of State of the State of Minnesota and the Town Clerk of Gordon Township, Carver County, Minnesota.

Section 4. Annexation shall be complete from and after the date when certified copies of this ordinance have been filed as directed in Section 3.
