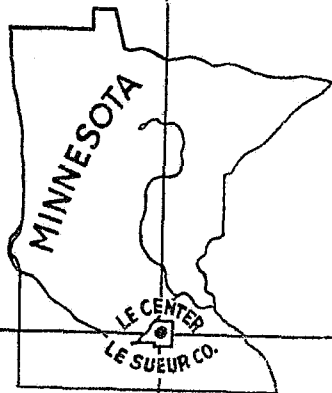

ORDINANCE NO. 105

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF LE CENTER TO INCLUDE CERTAIN UN-PLATTED LANDS NOT EXCEEDING 200 ACRES IN AREA ADJUTING UPON THE VILLAGE LIMITS

WHEREAS, petitions requesting the annexation of the territory hereinafter described was duly presented to the Village Council; and

WHEREAS, the quantity of land embraced within the area described in the petitions and bounded as described is less than 200 acres of unplatted land, no part of which is included within the limits of any incorporated city, village, or borough; and

WHEREAS, the petitions were signed by all the owners of said land; and

WHEREAS, no objections to the annexations have been received from the town boards, the county boards, or the governing body of any municipality whose boundaries abut upon the boundaries of the lands to be annexed; and

WHEREAS, the land described in the petition abuts upon the village limits at the North and West boundaries thereof;

NOW THEREFORE, the Council of the Village of Le Center, Minnesota, ordains:

SECTION 1. The Village Council hereby determines (1) that the annexations will be to the best interests of the village and of the territories affected; (2) that the territories described herein abuts upon the village limits and is urban or suburban in character; and (3) that none of said territories are now included within the limits of any city, village, or borough.

SECTION 2. Territory annexed. The corporate limits of the village are hereby ex-

tended to include the unplatted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

Parcel I, owned by Lyle Jerrow and Anna Jerrow, husband and wife, described as follows to-wit:

Commencing at a point 1235.5 feet South and 355.6 feet West of the center of Section number Twenty-nine (29), Township One Hundred Eleven (111), North, Range Twenty-Four (24) West, thence running Northerly 199.5 feet, thence running West 434.4 feet, more or less, to the East line of the West half (W1/2) of the Southwest Quarter (SW1/4) said section, Township and Range, thence running Southerly 199.5 feet, thence running Easterly 434.4 feet, more or less to the place

of beginning.

Parcel II, owned by Jasper T. Kraver and Rufinus Korman, described as follows to-wit:

The West 510 feet of North 292 feet of the South 378 feet of the Southeast Quarter of the Southwest Quarter, Section 23, Township 111, Range 24.

Parcel III, owned by Miles Bowler and Orelle Bowler, husband and wife, described as follows to-wit:

Beginning at a point 69 feet North and 205.5 feet West of the Northwest corner of Block 3, Center Park Addition to the Village of Le Center, thence West 330 feet, thence North 497 feet, thence East 469.5 feet, thence South 66 feet, thence West 139.5 feet, thence South 430 feet, to the place of beginning, being a part of the Northeast Quarter (NE1/4) of the

Northeast Quarter (NE1/4) of Section Twenty-nine (29), Township 111, Range 24.

Parcel IV, owned by Albert Gantz, described as follows to-wit:

Commencing at a point 63 feet North and 33 feet West of the Northwest corner of Hobday's Addition to the Village of Le Center, Le Sueur County, Minnesota, thence Northerly 499 feet, thence Easterly 157 1/2 feet, thence Southerly 499 feet, thence Westerly 157 1/2 feet to the place of beginning.

Parcel V, owned by Kenneth O'Malley and Aine O'Malley, husband and wife, described as follows, to-wit:

Beginning at a point 236.5 feet South and 1036.32 feet West of the Center of Section Twenty-nine (29) North, Range Twenty-Four (24) West, thence running in a Westerly direction 233.69 feet;

thence in a Southerly direction 199.5 feet, thence in an Easterly direction 333.69 feet, thence in a Northerly direction 199.5 feet to the place of beginning.

SECTION 3. Filing. The village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, Secretary of State and the County Auditor.

SECTION 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
