ORDINANCE NO. 152

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CORPORATE LIMITS OF THE CITY OF VACCHIA

thereas, the city of Vacanta has praviously purchased the lands hereinafter described and is the owner thorses; and

MARREAS, Minnesota Statutos Section 414.033 provides that lands which are exped by a municipality may be annexed by ordinance without further proceedings.

THE COMMON COUNCIL OF THE CITY OF HACONIA, CARVER COUNTY, MINNESOTA, ORDAINS:

Section 1. Declaration. It is hereby determined that the territory described below abouts the present corporate limits of the City of Vaconia; that said lands are not now included in any other municipality; that said lands are urban in character; and that said lands are coned by the City of Vaconia.

Section 2. <u>Territory Annexed</u>. The corporate limits of the City of Vacenia are hereby extended to encempass and embrace all of the territory described as follows, to-wit:

That part of the South Maif of the Northeast Quarter of Section 23, Termship 116, Ranga 25, Carver County, Minnesota, described as commencing at the point of intersection of the Southerly extension of the centerline of Maple Street as new laid out in the City of Maconia, Minnesota, with the North Time of the said South Half of the Northeast Quarter; thence West along said North Time of said South Malf of the Northeast Quarter a distance of 450 feet to a point to be Chereinafter known as Point X; thence Easterly along a line extending to a point on the Southerly extension of the centerline of said Maple Street distant 360 feet South from the point of commencement, said line to be hereinafter known as "Line A"; thence South along the said Southerly extension of Maple Street to the intersection with the location line for the right-of-way of State Highway No. 5 as recited in the final certificate of record in Book L of Miscellaneous page 560; thence Southwesterly along said Location line 436.44 feet; thence Northwesterly at right angles to said location line to the point of intersection with a line 200 feet Southerly of, measured at right angles to, and parallel with the aforementioned "Line A", said point of intersection being the actual point of beginning of the land to be described; thence continuing Northwesterly along said right angle line to the intersection with all of the Northeast Quarter to the Intersection with a line 200 feet Southerly of, measured at right angles to, and south Half of the Northeast Quarter to the Intersection with a line 200 feet Southerly of, measured at right angles to, and parallel with said "Line A"; thence Easterly along said parallel

Section 3. <u>Filing.</u> The City Clork is hereby directed to file cortified copies of this Ordinance with the Municipal Commission of the State of Minnesota, the Secretary of State, and the Auditor of Carver County.

Dection 4. Effective Date of Annexation. Annexation shall be deered final upon the filling of the certified copies as direct in Section 3.
