ORDINANCE NO. 301

BEING AN ORDINANCE RELATING TO THE ANNEXATION TO THE CITY OF LE SUEUR OF CERTAIN LANDS SITUATED IN RURAL OTTAWA TOWNSHIP, LE SUEUR COUNTY, MINNESOTA.

The Common Council of the City of Le Sueur do ordain:

Section 1. That pursuant to the provisions of Minnesota Statutes Annotated Section 414.033 Subdivision 5 the following described lands are hereby annexed by the City of Le Sueur and shall henceforth be included within and be a part of the corporate limits of the City of Le Sueur, Minnesota, to-wit:

All that part of the Southwest Quarter of the Southwest Quarter of Section 1, Township 111 North, Range 26 West described as follows: Beginning at a point on the South line of the Southwest Quarter of the Southwest Quarter of said Section 1, 350.00 feet East of the Southwest corner of the Southwest Quarter of the Southwest Quarter of said Section 1; thence Westerly along the South line 350.00 feet to said Southwest corner; thence North 0°-00' (assumed bearing) along the West line of the Southwest Quarter of the Southwest Quarter of said Section 1, 740.70 feet; thence North 89°-46' East and parallel to the North line of the Southwest quarter of the Southwest Quarter of said Section 1, 350.00 feet; thence South 0°-00' and parallel to the West line of the Southwest Quarter of the Southwest Quarter of said Section 1 to the point of beginning, said tract containing 5.95 acres, more or less; and also,

The West Half of the Northwest Quarter, Section 12, Township 111 North, Range 26 West. All of the above described lands being and lying in the County of Le Sueur, State of Minnesota.


Section 2. All the Ordinances and portions of Ordinances inconsistent herewith are hereby repealed.

This Ordinance shall be in force and take effect from and after its passage, publication and after filing copies hereof with the Minnesota Municipal Commission, the Le Sueur County Auditor, the Minnesota Secretary of State and the Town Board for Ottawa Township and after compliance with any and all other provisions of applicable law.
