

IT IS HEREBY ORDERED,



(3) That the aforesaid Gertrude Miller shall on or before July 1, 1970 execute the oath and give the bond required


by law of Clerks of the District Court before entering upon her
duties as Clerk of the District Court, Winona County, Minnesota.
