

ST. CLOUD METROPOLITAN TRANSIT COMMISSION

RESOLUTION LEVYING ST. CLOUD  
TRANSIT AREA WHEELAGE TAX

WHEREAS, Laws of Minnesota, 1969, Chapter 1134, Section 4, provides that the Transit Commission on or before August 1 of any year shall levy on all class St. Cloud Transit Area motor vehicles a Wheelage Tax, in the sum of \$1.00 per year for any succeeding calendar year or years, such tax being in addition to the state motor vehicles tax and other wheelage taxes, if any, and not subject to any limitations prescribed by law except as expressly provided under the Act.

BE IT RESOLVED, by the St. Cloud Metropolitan Transit Commission as follows:

1. The Commission hereby finds and determines that the Wheelage Tax authorized by law and in the amount levied hereby is necessary to carry out the purposes of the Act and to provide for the administrative expenses of the Commission.
2. A Wheelage Tax, known as the St. Cloud Transit Area Wheelage Tax, in the sum of \$1.00 per vehicle is hereby levied for the calendar year of 1971 and shall be collected and credited as provided by law.
3. The Secretary is hereby authorized and directed to certify a copy of this resolution to the State Registrar of Motor Vehicles on or before August 1, 1970, as required by law.
