Ordinance No 396

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN
LANDS ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition requesting annexation of the territory herein-
after described was duly presented to the Council on the 2nd day of February,
1970; and

WHEREAS, the quantity of land embraced within the area described in the peti-
tion and bounded as described is 2.50 acres of unplatted land, no part of which is
included within the limits of any incorporated city, village or borough; and

WHEREAS, the petition was signed by R. W. ANDERSON and N. M. ANDERSON, they
being all the owners of the premises therein described; and

WHEREAS, no objections to the annexation have been received from the town
board, the County Board, or the governing body of any municipality whose boundaries
abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the City
Westerly boundary thereof;

The City of Montevideo does ordain:

Section 1. The City Council hereby determines: (1) that the annexation will
be to the best interests of the City and of the territory affected; (2) that the
territory described herein abuts upon the City limits and is urban or suburban in
character; and (3) that none of said territory is now included within the limits
of any city, village or borough.

Section 2. Territory Annexed: The corporate limits of the City are hereby
extended to include the unplatted land described as follows and the same is hereby
annexed to and included within the city as effectually as if it had originally been
a part thereof:

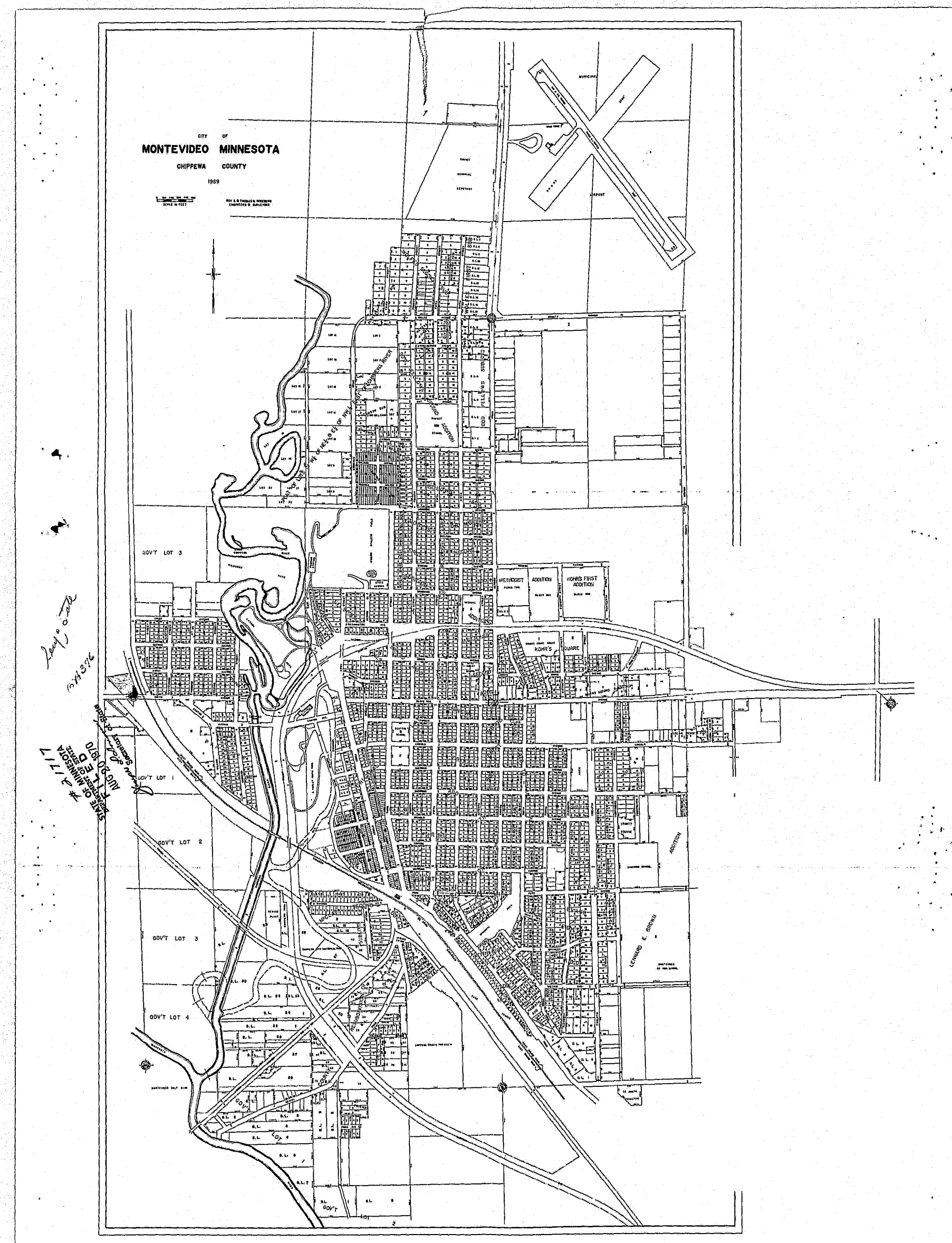
A tract of land in the Southeast Quarter (SE $\frac{1}{4}$) of the Southeast
Quarter (SE $\frac{1}{4}$) of Section Twelve (12), in Township One Hundred Seven-
teen (117), Range Forty-one (41), contained within a boundary line
described as follows: Commencing at the Southeast corner of said
Section Twelve (12) as the place of beginning, and running thence
North Four (4) chains and Twenty-eight (28) links to the new right-of-
way of the Chicago, Milwaukee and St. Paul Railway Company; thence
Northwesterly along the line of said new right-of-way of said Railway
Company, until the same intersects a line drawn parallel with the
South line of said section and Six (6) chains and Six (6) links North
therefrom; thence West Six (6) chains and Fourteen (14) links to the
line of the old right-of-way of said company; thence Southeasterly

along the Easterly line of said old right-of-way to the South line of said section; thence East One (1) chain and Eighty-three (83) links to the place of beginning, and containing 2.50 acres.

Section 3. That said premises are hereby annexed to and made a part of the City of Montevideo and are zoned as I2 - "Industrial District".

Section 4. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor and the Register of Deeds.

Section 5. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4.
