Ordinance No. 397

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN LANDS ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the Council on the 2nd day of February, 1970; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 8.9 acres, more or less, of unplatted land, no part of which is included within the limits of any incorporated city, village or borough; and

WHEREAS, the petition was signed by KUHLMANN & SMITH, INC., Kenneth Strand and Kathleen Strand, they being all the owners of the premises there-in described; and

WHEREAS, no objections to the annexation have been received from the town board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the Easterly boundary thereof;

The City of Montevideo does ordain:


Section 1. The City Council hereby determines: (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed: The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

The South Half (S½) of the Southwest Quarter (SW¼) of the Northwest Quarter (NW¼) of Section Eight (8), in Township One Hundred and Seventeen (117) North, Range Forty (40) west of the 5th P.M. Except that part therof which lies north of the north boundary of Fosnes Avenue in the City of Montevideo extended easterly and west of a line Two

Hundred and Thirty-five feet (235') east of and parallel to the center line of State Trunk Highway Twenty-nine (29), containing 8.9 acres more or less.

Section 3. That said premises are hereby annexed to and made a part of the City of Montevideo and are zoned as R "Residential District" subject to the condition that a mobile home park may be established on said premises upon securing a special use permit and complying with all ordinances of the City of Montevideo relating to mobile home parks.

Section 4. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor and the Register of Deeds.

Section 5. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4.
