ORDINANCE NO. 431

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MARSHALL TO INCLUDE CERTAIN UNPLATIED LAND NOT EXCEDING TWO HUNDRED ACRES.

The Common Council of the City of Marshall do ordain as follows:

UN IX

Section 1. Petitions have been filed with the Common Council of the City of Marshall, Minnesota, by the sole owners of the following described real estate in the County of Lyon, State of Minnesota, to have such land included within the City of Marshall, Minnesota:

> All that part of the Southwest Quarter (SW±) of Section Thirty-four (34), Township One Hundred Twelve (112), Range Forty-one (41), lying South and East of County Road Number Sixty-seven (67) as now laid out and existing; except the following portion thereof: Beginning at the Southwest corner of said Section Thirty-four (34), running thence North along the West section line a distance of 525 feet; thence East at right angles and parallel with the South line of Section Thirty-four (34) a distance of 433 feet; thence South at right angles and parallel with the West line of Section Thirty-four (34) a distance of 525 feet; thence West at right angles along the South line of Section Thirty-four (34), 433 feet to the place of beginning, said tract conveyed containing 124.8 acres more or less; all subject to existing roadways, highways and easements.

All that part of the Southwest Quarter of the Southwest Quarter (SW1SW1) of Section Thirty-four (3+), Township One Hundred Twelve (112), Range Forty-one (41) West of the Fifth Principal Meridian, described as follows, towit: Commencing at the Southwest corner of said Section 34; thence north on the west line of said Section 34 a distance of 85 feet; thence east and parallel with the south line of said Section 34 a distance of 433 feet; thence south and parallel with the west line of said Section to the South line of said section; thence west along the south line of said section to the point of beginning, and excepting therefrom the right-of-way of existing roads.

Section 2. The quantity of land embraced within the foregoing descriptions, and bounded and described, is <u>125.6</u> acres, more or less.

Section 3. The Common Council hereby determines (1) that the annexation will be to the best interests of the City of Marshall, Minnesota and of the territory affected; and (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 4. Therefore, the City of Marshall, Minnesota hereby ordains and declares that the properties hereinbefore described be and the same are hereby annexed to, and included in, the City of Marshall, Minnesota, as effectually as if they had been originally a part hereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the town clerk of Fairview Township, the County Auditor of Lyon County and the Secretary of State, and from and after its passage and publication.
