ORDINANCE NO. 1512
AN ORDINANCE Annexing to the City of Rochester, Minnesota, Certain Unplatted Land in Cascade Township, Sections Twenty-One, Twenty-Two and Twenty-Eight, Township One Hundred Seven North, Range Fourteen West, Olmsted County, Minnesota, Which is Completely Surrounded by Land Within the City of Rochester, Minnesota.

THE COMMON COUNCIL OF THE CITY OF ROCHESTER DO ORDAIN:

Section 1. The following described unplatted lands in Cascade Township, Sections 21, 22 and 28, Township 107 north, Range 14 west, Olmsted County, Minnesota, are completely surrounded by land within the municipal limits of the City of Rochester:

Commencing at the intersection of the north right-of-way of County State Aid Highway No. 4 and the west line of the NE 1/4 of Sect. 28, T107N, R14W for a place of beginning; Thence north along the west line of the NE 1/4 of Sect. 28 to its intersection with the north line of the NE 1/4 of Sect. 28, T107N, R14W; thence east along the north line of Section 28 to its NE corner and continuing east along the south line of the SW 1/4 of Section 22, T107N R14W to the point of intersection of a line that lies parallel to and 280.0 feet westerly (measured at right angles to the centerline) of Trunk Highway 52-20 as it existed in March 1956, thence northwesterly along said line to its intersection with the north line of the south half of the SW 1/4 of Section 22, thence west along the north line of the south half of the SW 1/4 of Section 22 and along the north line of the south half of the SE 1/4 of Section 21 to the west line of said SE 1/4, thence south along the west line of the SE 1/4 of Section 21 to a point that is 48 rods north of the SE corner of the SW 1/4 of Section 21, thence west 12 rods, thence south 16 rods, thence east 12 rods, thence south 32 rods to the SE corner of the SW 1/4 of Section 21, thence west along the south line of the SW 1/4 of Section 21 to its intersection with the north right-of-way line of County State Aid Highway No. 4, thence southeasterly along said northerly right-of-way to the place of beginning.

Section 2. The quantity of unplatted land described in Section 1 above is approximately 124.08 acres.

Section 3. The Common Council of the City of Rochester do hereby determine that the lands described in Section 1 are urban in character, are so conditioned as to be properly subjected to municipal government, and the annexation of said lands will be in the best interests of the City of Rochester and of the lands affected.

Section 4. Therefore, the lands described in Section 1 above are hereby annexed, added to and made a part of the City of Rochester, Minnesota, as effectually as if they had originally been a part thereof.

Section 5. Pursuant to Ordinance No. 1466 which establishes an urban service district and a rural service district as separate taxing districts within the City of Rochester, the lands described in Section 1 above are hereby declared to be in the rural service district. Such classification shall apply to taxes due and payable in 1970 and thereafter.

Section 6. Present and future owners of the area annexed by this ordinance are hereby notified that in addition to the usual assessments, it is the intention of the Common Council to assess against benefited property all or a portion of the cost of any storm sewer, water tower and trunk line sanitary sewer construction, heretofore or hereafter, undertaken to serve the area annexed.

Section 7. Present and future owners of the area annexed by this ordinance are hereby notified that by such annexation, the City of Rochester does not commit itself to extend its services and make local improvements in the area annexed; and that the City of Rochester, through its Common Council, specifically reserves the right to annex additional areas to the City of Rochester and extend City services and make local improvements to such other later annexed areas in advance of improvements to the area hereby annexed if the same appears more reasonable and economical.

Section 8. This ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the Cascade Town Clerk, the County Auditor and the Secretary of State.
