AN ORDINANCE ADDING LAND TO THE CORPORATE LIMITS OF THE CITY OF  
NEW PRAGUE

The City Council of the City of New Prague do ordain:

That in accordance with Section 624.03, Minnesota Statutes  
designated the following described parcel of land located in  
Lanesburgh Township, Le Sueur County, Minnesota, is herewith  
admitted to the corporate limits of the City of New Prague:

All that part of the Southeast Quarter of Section Three (3),  
Township One Hundred Twelve (112) North, Range Twenty-three  
(23) West, described as follows, to-wit: Beginning at the  
Northeast Corner of said Southeast Quarter (3rd) of said  
Section Three (3) and running thence South along the  
section line a distance of 1759.2 foot, running thence West,  
a distance of 1524.5 foot, running thence North a distance of  
2150.0 foot, running thence West a distance of 391.0 foot,  
running thence North a distance of 570.1 foot, and running  
thence East a distance of 1936.5 foot to the point of  
beginning.
