## ORDINANCE NO. 54

AN ORDINANCE AMMEXING TERRITORY TO THE VILLAGE OF CLEARBROOK, MINNESOTA

BE IT ORDAINED BY THE VILLAGE OF CLEARBROOK, MINNESOTA, AS FOLLOWS:

That the real estate hereinafter described, owned by the Village of Clearbrook, and abutting upon the incorporated portion of the Village of Clearbrook, said tract or parcel of land located in the County of Clearwater, State of Minnesota, to-wit:

All that part of the Southeast Quarter of the Northeast Quarter (SEANEW) of Section Thirty (30), Township One Hundred Forty-nine (149) North, Range Thirty-seven (37) West, of the Fifth P.M., described as follows, to-wit:

Commencing at a point 1000 feet West of the Northeast Corner of said SEMNEA. Section 30, as the point of beginning; theace East along the quarter line 1000 feet; thence South along the quarter line 210 feet; thence at right angles and West 350 feet; thence at right angles and South 300 feet; thence at right angles and West 288.1 feet more or less to the railroad right-of-way line; thence in a Northwesterly direction along the right-of-way line 417 feet more or less to a point directly south of the point of beginning; thence North 306.4 feet more or less to the point of beginning;

be and the same is hereby annexed to, incorporated in, and made a part of the incorporated territory of the Village of Clearbrook, Minnesota.
