ORDINANCE NO. 190 - B.

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SARTELL TO INCLUDE UNINCORPORATED PROPERTY ADJACENT UPON THE VILLAGE LIMITS AND NOT EXCEEDING TWO HUNDRED ACRES IN AREA.

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the Village of Sartell on the 21st day of April, 1970; and,

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described herein is not in excess of 200 acres of unplatted and platted land, no part of which is included within the limits of an Incorporated City, Village or Borough; and,

WHEREAS the Petition was signed by all of the owners of said land; and, WHEREAS no objection to the annexation has been received from the Town Board, the County Commissioners or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and,

WHEREAS the land described in the Petition abuts upon the Village limits on the Northerly side thereof, NOW, THEREFORE:

THE COUNCIL OF THE VILLAGE OF SARTELL, MINNESOTA, ORDAINS AS FOLLOWS:

Subsection 1. Its Village Council hereby determines that the annexation will be to the best interest of the Village and of the territory affected; that the territory described herein abuts upon the Village limits and is about to become urban or suburban in character; and that none of said territory is now included within the limits of any Incorporated City, Village or Borough.

Subsection 2. Territory Annexed. The Corporate Limits of the Village of Sartell are hereby extended to include the unplatted and platted lands described as follows and the same are hereby annexed to and included within the Village as effectually as if it had originally been a part thereof, to-wit:

"A tract of land lying in and being a part of Government Lot Four (4) in Section 16, Township 125 North, Range 23 West, described as follows: Beginning at the Southeast Corner of said Government Lot 4, Section 16, Township 125 N. Range 23 W.; thence due East along the South line of said Government Lot 4 to a point of intersection with the Easterly right of way line of State Highway No. 1, as now established and travelled; thence Northerly along said Easterly right of way line of said road to a point 33 feet due North of the South line of Government Lot 4; thence due West and parallel with said South line of said Government Lot 4 to a point of intersection with the Easterly line of the alley now existent in Block 2 of the Partial Re-arrangement of the Village of Sartell, extended Northerly;

thence southerly and parallel with the westerly right of way line of said State Aid Road No. 1 for a distance of 122 feet; thence due east and parallel with said South Line of said Government Lot 4 to a point on the westerly bank of the Mississippi River; thence southerly along said westerly bank of said River to the southeasterly corner of said Government Lot 4 to the point of beginning and there terminating.

Also out Lot No. Two (2) and all of that part of out Lot No. Three (3) lying southerly of a line described as follows: commencing at the southwest corner of out Lot No. 1 and running thence in a southwesterly direction across out Lot No. 3 at right angles to the westerly boundary line of out Lot No. 1, all in First Addition to Winona City, a platted subdivision in Le Sueur Township, Stearns County, Minnesota.

Also all that part of Seventh Street North of Village of Sartell lying south of above numbered roadway and not now within the corporate limits of the Village.

Said property being annexed to the Village of Sartell under Zoning Classification of R-1, excepting public road right of way.

Subsection 2. Filing. The Village Clerk is hereby directed to file certified copies of this ordinance with the Secretary of State, the Stearns County Auditor, the Township of Le Sueur and the Minnesota Municipal Corporation.

Subsection 4. Effective Date of Appropriation. This Ordinance will take effect upon the passage and publication and the filing of the certified copies as herein directed.
