AN ORDINANCE AMENDING ORDINANCE NO. 1474 ENTITLED "AN ORDINANCE ANNEXING TO THE CITY OF ROCHESTER, MINNESOTA, CERTAIN PLATTED LAND IN NORTH SUNNY SLOPES, OLISTED COUNTY, MINNESOTA"

THE COMMON COUNCIL OF THE CITY OF ROCHESTER DO ORDAIN:

Section 1. In order to correct an error in the description of property annexed to the City of Rochester, Section 1 of Ordinance No. 1474 entitled "An Ordinance Annexing to the City of Rochester, Minnesota, Certain Platted Land in North Sunny Slopes, Olmsted County, Minnesota," which reads as follows:

"Lot Fifty-four (54, North Sunny Slopes."

is hereby amended to read:

"Lot 54, North Sunny Slopes less commencing at the northeasterly corner of Lot 54, North Sunny Slopes for a place of beginning and running thence due west along the north line of said lot a distance of 272.15 feet, thence south 48° 29' east a distance of 137.73 feet to a point in the north line of Skyline Drive in the above subdivision, thence deflect in a northeasterly direction along the north right of way line of said Skyline Drive a distance of 155.60 feet on a curve Delta angle 380 40' Radius 230.57 feet to the place of beginning.'

Section 2. This ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, and the Olmsted County Auditor and the Secretary of State.
