## ORDINANCE NO. 363

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HUTCHINSON AND ANNEXING THERETO CERTAIN ALND FORMERLY LOCATED IN THE TOWNSHIP OF LYNN

THE CITY OF HUTCHINSON DOES ORDAIN:

Section I: A petition has been filed with the governing body of the City of Hutchinson, Minnesota, by Kenneth F. Born for Midwest Modules, Inc.; Russell E. Haigh; Orville J. Lund; Edna A. Lund; Alvina Steffenson and S. P. Steffenson, being one hundred percent sole owners of the following described real property, to have said property annexed and included within the corporate limits of the City of Hutchinson, Gounty of McLeod, State of Minnesota, to-wit:
