ORDINANCE NO. 356

AN ORDINANCE ANNEXING CERTAIN LANDS IN THE
TOWNSHIP OF NORTH, PENNINGTON COUNTY, MINNESOTA
TO THE CITY OF THIEF RIVER FALLS, MINNESOTA

The City Council of the City of Thief River Falls do hereby
ordain as follows:

SECTION 1.

Whereas the following described lands in the Township of
North, County of Pennington and State of Minnesota are more
than Sixty Per Cent (60%) bordered by the City of Thief River
Falls and Notice of Intent to Annex the same has been served
upon the town board of said township as required by law and no
objection has been filed within the time specified by statute,
the City Council does, therefore, hereby declare the following
described lands to be annexed to the City of Thief River Falls,
Minnesota:

Parcel No. 1

Beginning at the northeasterly corner of Lot 10,
Block 1, Sherwood Forest Addition; thence S. $20^{\circ} 21' 34''$ E. a distance of 35 feet; thence S. $28^{\circ} 04' 30''$ E. to the centerline of the Red Lake River, thence meandering westerly along the said centerline to an intersection with the West line of Section 35, T.154 N., R.43W; thence due North along the said West Section line to the Northwest corner of Lot 7, Block 1, Sherwood Forest Addition; thence easterly along the northerly lot lines of Lots 7, 8 and 9, Sherwood Forest Addition to the Northeast corner of said Lot 9; thence N. $30^{\circ} 00' 35''$ W. a distance of 30.0 feet; thence N. $69^{\circ} 09' 46''$ E. a distance of 108.124 feet to the point of beginning containing 4.9 Acres more or less.

Parcel No. 2

Beginning at the centerline of the Red Lake River and the West property line of Lot 53 Rustad's Subdivision Extended; thence in a northerly direction along the West line of said Lot 53 to the centerline of the East-West Cart Way; thence easterly along the centerline of said Cart Way to an intersection with a line 15 feet West of the East line of Lot 56 extended; thence southerly along a line 15 feet West of the East line of Lot 56, Rustad's Subdivision to an intersection with the centerline of the Red Lake River; thence northwesterly along the centerline of said River to the point of beginning containing 9.4 Acres more or less.

Parcel No. 3

Beginning at the centerline of the Red Lake River and the easterly property line of Lot 51, Rustad's Subdivision Extended; thence meandering northwesterly along the said centerline to an intersection with the centerline of the North-South Cart Way Extended; thence northerly along the centerline of said Cart Way to the northerly line of Lot 19, Rustad's Subdivision Extended; thence westerly along the North line of said Lot 19 to the East line of Lot 11, Rustad's Subdivision; thence southerly along the East line of said Lot 11 to an intersection with the centerline of the Red Lake River; thence meandering northwesterly along the said centerline to an intersection with the centerline of the Thief River; thence northerly along the centerline of said Thief River to an intersection with the northerly Right of Way line of Minnesota Trunk Highway No. 1 extended westerly; thence easterly along the northerly Right of Way line of said Trunk Highway No. 1 to an intersection with the centerline of the North-South Cart Way in Rustad's Subdivision Extended; thence southerly along the said centerline to an intersection with the centerline of the East-West alley between Lots 21 and 34, Rustad's Subdivision; thence easterly along said centerline to an intersection with a line, which line is a line 50 feet West and parallel to the East line of Lot 36, Rustad's Subdivision; thence southerly along said line to the centerline of the East-West Cart Way; thence easterly along said centerline to an intersection with the East line of Lot 51 extended northerly, thence southerly along said East line to the point of beginning containing 62.8 Acres more or less.

SECTION 2.

This ordinance shall be in force and effect from and after its passage, approval, publication and filing of copies thereof with the Minnesota Municipal Commission, the Town Clerk of North Township, the Pennington County Auditor and the Secretary of State of the State of Minnesota.
